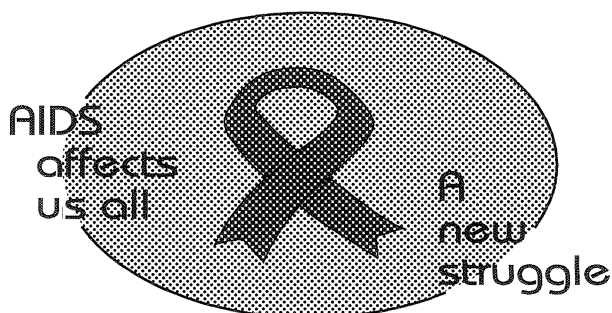

No. 106**14 May 2014****Public Notice Calling for Inspection of the First Supplementary Valuation Roll and Lodging of Objections**

Notice is hereby given in terms of Section 49(1)(a)(i) of the Local Government Property Rates Act 2004 (Act No 6 of 2004) hereinafter referred to as the "Act" that the first supplementary valuation roll prepared in terms of Section 78 of the Act for the financial year 1 July 2013 to 30 June 2014 will be open for public inspection at the municipal offices.

An invitation is hereby made in terms of Section 49(1)(a)(ii) of the Act that any owner of property or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from the supplementary roll.

The roll will be open for inspection from 2 May 2014. The closing date for objections is 13:00 on Monday, 30 June 2014.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act an objection must be in relation to specific individual property and not against the supplementary roll as such.

Objection forms are obtainable from the Municipal Offices (Room 10).
