I, Nomusa Dube-Ncube, in my capacity as Member of the KwaZulu-Natal Executive Council responsible for local government, and under powers vested in me by section 14(5) of the Local Government: Municipal Structures Act, 1998 (Act No.117 of 1998), and after having consulted the affected municipalities in the Province, hereby make the transitional measures contained in the Schedule hereto.

SCHEDULE**DEFINITIONS**

1. In this Schedule a word or expression, to which a meaning has been assigned in the Municipal Structures Act, has the same meaning, and unless the context indicates otherwise –

“**Committees**” means the Municipal Political and Technical Change Management Committees established by paragraph 2;

“**disestablished municipalities**” means the following municipalities to be disestablished by the redetermination of boundaries in terms of section 21 of the Local Government: Municipal Demarcation Act, 1998 (Act No. 27 of 1998) –

(a) Ntambanana Local Municipality; and

(b) Vulamehlo Local Municipality;

“**existing municipalities**” means the municipalities with which the disestablished municipalities, or part thereof, will be incorporated in terms of the redetermination of boundaries as set out in *Extraordinary Provincial Gazette*, dated 23 October 2013;

“**MEC**” means the Member of the Executive Committee responsible for local government in the Province; and

“**Municipal Structures Act**” means the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998).

OBJECT OF TRANSITIONAL MEASURES

2. The object of the transitional measures set out in this Schedule is to facilitate the incorporation of the disestablished municipalities into the existing municipalities.

ESTABLISHMENT OF THE MUNICIPAL POLITICAL CHANGE MANAGEMENT COMMITTEE

3.(1) A facilitation committee called the Municipal Political Change Management Committee is hereby established.

(2) The main objectives of the Committee are to –

- (a) act as a consultative and advisory forum for the MEC concerning the incorporation of the disestablished municipalities in the existing municipalities;
- (b) support and guide the incorporation in the restructuring process, unblocking blockages where occurring and ensuring compliance with regard to laid down time frames and legislative requirements; and
- (c) ratify recommendations made by the Municipal Technical Change Management Committee and report to the affected municipalities.

(3) To achieve these objectives it will receive technical reports from a Municipal Technical Change Management Committee established for this purpose in terms of paragraph 4 of this Schedule.

ESTABLISHMENT OF A MUNICIPAL TECHNICAL CHANGE MANAGEMENT COMMITTEE

4.(1) A facilitation committee called the Municipal Technical Change Management Committee is hereby established.

(2) The function of the Municipal Technical Change Management Committee shall be to recommend to the Municipal Political Change Management Committee measures regarding –

- (a) the transfer of staff from the disestablished municipalities to the existing municipalities as well as the filling of vacancies during the transitional period;
- (b) the drafting of a new organogram for the existing municipalities;
- (c) the transfer of the assets, rights, liabilities and obligations of the disestablished municipalities to the existing municipalities;
- (d) the transfer of administrative and other records relating to the assets, rights, liabilities and obligations of the disestablished municipalities to the existing municipalities;
- (e) the rationalisation of by-laws and policies of the disestablished municipalities for implementation by the existing municipalities, and the continued application of the by-laws, regulations and resolutions of the disestablished municipalities on, or in, the existing municipalities and the extent of such application;
- (f) the alignment of the Integrated Development Plans of the affected municipalities for adoption by the new municipalities;
- (g) the integration of the budgets of the disestablished municipalities for adoption by the existing municipalities, where applicable;
- (h) the acquisition and disposal of assets with a value exceeding R500 000.00 (five hundred thousand rand);
- (i) the negotiation and approval of long term loans and the utilisation of reserves;
- (j) designation of full-time councillors; and
- (k) the facilitation, in any other manner, of the disestablishment of the affected municipalities.

COMPOSITION OF CHANGE MANAGEMENT COMMITTEES

5.(1) The Municipal Political Change Management Committee shall consist of –

- (a) the district mayor or deputy mayor;
- (b) mayors of existing municipalities;
- (c) speakers of existing municipalities;
- (d) two Members of the Executive Committee, in the case of a municipality with a collective executive system or, in the case of a municipality with a plenary executive system, two councillors as designated by the Council;
- (e) a maximum number of three *amaKhosi* from the existing municipalities, as determined by the Local House of Traditional Leaders; and

(f) representatives of SALGA (KZN).

(2) The Municipal Technical Change Management Committee shall consist of –

- (a) the district municipal manager;
- (b) the municipal managers of the existing municipalities;
- (c) the heads of departments of the existing municipalities;
- (d) local union representatives (one representative per union);
- (e) the departmental transformation manager; and
- (f) representatives of SALGA (KZN).

CONDUCT OF MEMBERS

6.(1) A member of a Committee must perform the functions of office –

- (a) in good faith; and
- (b) without fear, favour or prejudice.

(2) A member of a Committee may not –

- (a) use the position or privileges of a member for private gain or to improperly benefit another person; or
- (b) act in any other way that compromises the credibility, impartiality or integrity of the Committee.

MEETINGS OF THE COMMITTEES

7.(1) The chairperson of the Committee decides where and when the Committees meet, but a majority of the members may request the chairperson, in writing, to convene a meeting of the Committee at a place and time set out in the request.

(2) The chairperson presides at the meeting of the Committees, but if the chairperson is absent from a meeting, the members present must elect another member to preside at the meeting.

SUBCOMMITTEES

8. The Committees may establish subcommittees to assist the Committees in the performance of their functions or the exercise of any of their powers.

ADMINISTRATIVE ASSISTANCE TO COMMITTEES

9. The district municipality of the affected municipalities must provide administrative and secretarial services to the Committees.

- (i) nokutholakala nokuchithwa kwempahla ebiza inani elevile kwizi-R500000.00 (izinkulungwane ezinhlanu zamakhulu amarandi);
- (j) nokuxoxisana nokugunyazwa kwemalimboleko yesikhathi eside nokusetshenziswa kwezimali ezigciniwe;
- (k) nohlobo lomasipala;
- (l) amandla kamasipala nemisebenzi kamasipala omusha;
- (m) ukuqashwa kwamakhansela azosebenza ngokugcwele;
- (n) inqubo ehlongozwayo ezolandelwa ukuze kunqunywe igama likamasipala omusha;

(o) ukuhola, nganoma eyiphi indlela, ukuchithwa komasipala abathintekayo nokusungulwa komasipala abasha.

BYLAE**OMSKRYWINGS**

1. In hierdie Bylae het 'n woord of uitdrukking, waaraan 'n betekenis in die Wet op Munisipale Strukture toegeken is, dieselfde betekenis, en tensy uit die samehang anders blyk, beteken –

“**bestaande munisipaliteite**” die munisipaliteite waarby die ontbinde munisipaliteite, of 'n gedeelte daarvan, geïnkorporeer sal word ingevolge die herbepaling van grense soos uiteengesit in Buitengewone Provinsiale *Koerant*, gedateer 23 Oktober 2013;

“**Komitees**” die Bestuurskomitees: Munisipale Politieke Verandering en Munisipale Tegniese Verandering ingestel deur paragraaf 2;

“**LUR**” die Lid van die Uitvoerende Raad verantwoordelik vir plaaslike regering in die Provinsie;

“**ontbinde munisipaliteite**” die volgende munisipaliteite wat ontbind sal word deur die herbepaling van grense ingevolge artikel 21 van die Wet op Plaaslike Regering: Munisipale Afbakening, 1998 (Wet No. 27 van 1998) –

- (a) Ntambanana Plaaslike Munisipaliteit; en
- (b) Vulamehlo Plaaslike Munisipaliteit; en

“**Wet op Munisipale Strukture**” die Wet op Plaaslike Regering: Munisipale Strukture, 1998 (Wet No. 117 van 1998).

OOGMERK VAN OORGANGSMAATREËLS

2. Die oogmerk van die oorgangsmatreëls uiteengesit in hierdie Bylae is die fasilitering van die inkorporasie van die ontbinde munisipaliteite in die bestaande munisipaliteite.

INSTELLING VAN DIE BESTUURSKOMITEE: MUNISIPALE POLITIEKE VERANDERING

3.(1) Hiermee word 'n fasiliteringskomitee wat die Bestuurskomitee: Munisipale Politieke Verandering genoem word ingestel.

(2) Die hoofogmerke van die Komitee is om –

- (a) as 'n raadplegende en adviserende forum vir die LUR aangaande die inkorporasie van die ontbinde munisipaliteite in die bestaande munisipaliteite op te tree;
- (b) die inkorporasie in die herstruktureringproses te ondersteun en leiding te verskaf en, waar dit voorkom, hindernisse uit die weg te ruim en nakoming met betrekking tot die tydraamwerke en neergelegde wetgewende vereistes te verseker; en
- (c) aanbevelings wat deur die Bestuurskomitee: Munisipale Tegnieese Verandering gemaak word te bekragtig en verslag te lewer aan die munisipaliteite wat geraak word.

(3) Om hierdie oogmerke te bereik sal hy tegnieese verslae vanaf 'n Bestuurskomitee: Munisipale Tegnieese Verandering, ingestel vir hierdie doel ingevolge paragraaf 4 van hierdie Bylae, ontvang.

INSTELLING VAN 'N BESTUURSKOMITEE: MUNISIPALE TEGNIESE VERANDERING

4.(1) Hiermee word 'n fasiliteringskomitee wat die Bestuurskomitee: Munisipale Tegnieese Verandering genoem word ingestel.

(2) Die funksie van die Bestuurskomitee: Munisipale Tegnieese Verandering sal wees om maatreëls aan die Bestuurskomitee: Munisipale Politieke Verandering aan te beveel met betrekking tot –

- (a) die oorpasing van personeel vanaf die ontbinde munisipaliteite na die bestaande munisipaliteite, asook die vul van vakatures tydens die oorgangstydperk;
- (b) die opstel van 'n nuwe organogram vir die bestaande munisipaliteite;
- (c) die oorpasing van die bates, regte, laste en verpligtinge van die ontbinde munisipaliteite na die bestaande munisipaliteite;
- (d) die oorpasing van administratiewe en ander rekords rakende die bates, regte, laste en verpligtinge van die ontbinde munisipaliteite wat geraak word na die bestaande munisipaliteite;
- (e) die rasionalisering van verordeninge en beleide van die ontbinde munisipaliteite vir inwerkingstelling deur die bestaande munisipaliteite en die voortgesette toepassing van die verordeninge, regulasies en resolusies van die ontbinde munisipaliteite op, of in, die bestaande munisipaliteite en die omvang van sodanige aansoek;
- (f) die berigting van die Geïntegreerde Ontwikkelingsplanne van die munisipaliteite wat geraak word vir aanvaarding deur die nuwe munisipaliteite;
- (g) die integrasie van die begrotings van die ontbinde munisipaliteite vir aanvaarding deur die nuwe munisipaliteite, waar toepaslik;
- (h) die verkryging en vervreemding van bates met 'n waarde wat R500 000.00 (vyf honderd duisend rand) oorskry;
- (i) die onderhandeling en goedkeuring van langtermynlenings en die aanwending van reserwes;
- (j) aanwysing van voltydse raadslede; en
- (k) die fasilitering, op enige ander wyse, van die ontbinding van die munisipaliteite wat geraak word.

SAMESTELLING VAN BESTUURSKOMITEES: VERANDERING

5.(1) Die Bestuurskomitee: Munisipale Politieke Verandering sal bestaan uit –

- (a) die distriksburgemeester of -onderburgemeester;
- (b) burgemeesters van bestaande munisipaliteite;
- (c) speakers van bestaande munisipaliteite;
- (d) twee Lede van die Uitvoerende Komitee, in die geval van 'n munisipaliteit met 'n kollektiewe uitvoerende stelsel of, in die geval van 'n munisipaliteit met 'n voltallige uitvoerende stelsel, twee raadslede soos bepaal deur die Raad;
- (e) hoogstens drie *amaKhos*i vanuit die bestaande munisipaliteite, soos bepaal deur die Plaaslike Huis van Tradisionele Leiers; en

(f) verteenwoordigers van die Suid-Afrikaanse Plaaslike Regeringsvereniging, SALGA (KZN).

(2) Die Bestuurskomitee: Munisipale Tegniese Verandering sal bestaan uit –

- (a) die munisipale distriksbestuurder;
- (b) die munisipale bestuurders van die bestaande munisipaliteite;
- (c) die departementshoofde van die bestaande munisipaliteite;
- (d) plaaslike unieverteenwoordigers (een verteenwoordiger per unie);
- (e) die departementele transformasiebestuurder; en
- (f) verteenwoordigers van SALGA (KZN).

GEDRAG VAN LEDE

6.(1) 'n Komiteelid moet die werksaamhede van die amp –

- (a) te goeder trou; en
- (b) sonder vrees, guns of vooroordeel,

verrig.

(2) 'n Komiteelid kan nie –

- (a) die posisie of voorregte van 'n lid gebruik vir privaat gewin of om 'n ander persoon onbehoorlik te bevoordeel nie; of
- (b) op enige ander wyse optree wat die geloofwaardigheid, onpartydigheid of integriteit van die Komitee benadeel nie.

VERGADERINGS VAN DIE KOMITEES

7.(1) Die voorsitter van die Komitee besluit wanneer en waar die Komitees vergader, maar 'n meerderheid van die lede kan die voorsitter, skriftelik, versoek om 'n vergadering van die Komitee te belê op 'n tyd en plek soos uiteengesit in die versoek.

(2) Die voorsitter sit voor by die vergadering van die Komitees, maar indien die voorsitter afwesig is van 'n vergadering, moet die lede teenwoordig 'n ander lid verkies om voor te sit by die vergadering.

SUBKOMITEES

8. Die Komitees kan subkomitees instel om die Komitees by te staan met die uitvoering van hul werksaamhede en verrigting van enige van hul bevoegdhede.

ADMINISTRATIEWE BYSTAND AAN KOMITEES

9. Die distriksmunisipaliteit of die munisipaliteite wat geraak word moet administratiewe en sekretariële dienste aan die Komitees verskaf.
