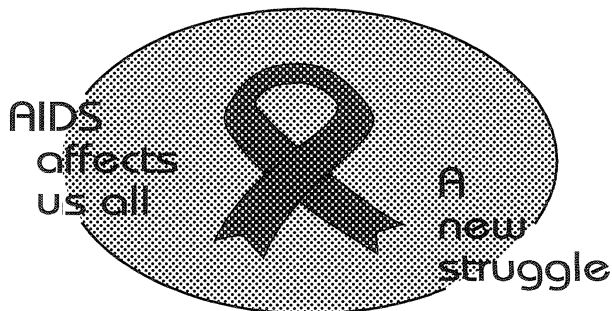

R.R. PILLAY, MPL, AS MEMBERS OF THE KWAZULU-NATAL RENTAL HOUSING
TRIBUNAL**

1. Nominations are hereby invited for candidates to be appointed by the KwaZulu-Natal MEC for Human Settlements and Public Works, Mr R.R. Pillay, as members of the KwaZulu-Natal Rental Housing Tribunal.
2. This is in terms of section 9 of the Rental Housing Act (Act No. 50 of 1999) which empowers the MEC to appoint members of the KwaZulu-Natal Rental Housing Tribunal.
3. The core function of the Tribunal is the resolution of disputes between tenants and landlords arising out of unfair practices.
4. Each candidate shall be nominated separately.
5. Each candidate must have knowledge and expertise:-
 - 5.1 in property management or housing development matters;
 - 5.2 in consumer matters pertaining to rental housing or housing development matters;
 - 5.3 in legal matters with practical court experience; and/ or
 - 5.4 in conflict resolution and have persuasive qualities.
6. The Tribunal members should hold a good profile in society in general to ensure that the credibility of the Rental Housing Tribunal and its decisions are adhered to by the parties.
7. The appointment of the Tribunal members shall be for a period not exceeding three years.
8. Nominations must be made in writing to the KwaZulu-Natal Department of Human Settlements by no later than 26 September 2014 and must be accompanied by a brief motivation and the curriculum vitae of the candidates.
