The Board also reserves the right to, when making the final awards, issue conditions with the aim of protecting and pursuing the interests of the shareholders or any persons who come from the historically disadvantaged communities in compliance with the Board's objects as enunciated in section 6 (1) (c); (d); (e) and (f) of the KZN Gaming and Betting Act (Act No. 8 of 2010), which would result in the right being revoked should an awardee fail to comply with such conditions.

Once the KwaZulu-Natal Gaming and Betting Board has made the final awards, each awardee will be required to make an application for a bookmaker licence in terms of section 94 of the KZN Gaming and Betting Act 8 of 2010 within four (4) months in respect of the districts and defined locations referred to above, which will be subject to publication notices for public inspection as prescribed by the KwaZulu-Natal Gaming and Betting Act (Act No. 8 of 2010)
