1. The Member of the KwaZulu-Natal Executive Council responsible for Co-operative Governance and Traditional Affairs, in her capacity as Member of the Executive Council responsible for local government, and under the powers vested in her by section 16(1)(d) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), to amend notices issued in terms of section 12 of the said Act, and in order to give effect to a decision by the Municipal Council of the uThungulu District Municipality to designate the Chairperson of the Municipal Public Accounts Committee as a full-time Councillor, proposes to publish the following notice:
