I, Nomusa Dube-Ncube, in my capacity as Member of the KwaZulu-Natal Executive Council responsible for local government, and under powers vested in me by section 14(5) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), after having consulted the affected municipalities in the Province, hereby provide for the transitional measures contained in the Schedule hereto.

SCHEDULE**DEFINITIONS**

1. In this Schedule a word or expression, to which a meaning has been assigned in the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), has the same meaning, and unless the context indicates otherwise –

“**affected municipalities**” means the following municipalities affected by the redetermination of boundaries in terms of section 21 of the Local Government: Municipal Demarcation Act, 1998 (Act No. 27 of 1998), as set out in Provincial Notice No. 57 published in the KwaZulu-Natal Provincial *Gazette* No. 1042 dated 23 October 2013:

- (a) Kwa Sani/ Ingwe Local Municipalities;
- (b) Hlabisa/ Big Five False Bay Local Municipalities;
- (c) Emnambithi/ Ladysmith/ Indaka Local Municipalities;
- (d) Hibiscus Coast/ Eziqoleni Local Municipalities;
- (e) Umtshezi/ Imbabazane Local Municipalities;
- (f) Ntambanana/ Mthonjaneni/ uMhlatuze/ uMfolozi Local Municipalities; and
- (g) Umdoni/ Vulamehlo/ eThekweni Metro;

“**committees**” means the Municipal Political Change Management and Municipal Technical Change Management Committees, established in terms of Provincial Notice No. 64 published in the KwaZulu-Natal Provincial *Gazette* No. 1168 dated 26 June 2014; and

“**MEC**” means the KwaZulu-Natal Member of the Executive Committee responsible for local government.

OBJECT OF TRANSITIONAL MEASURES

2. The object of the transitional measures set out in this Schedule is to facilitate the restructuring of the affected municipalities.

ESTABLISHMENT OF THE PROVINCIAL TRANSFORMATION COMMITTEE

3.(1) A facilitation committee called the Provincial Transformation Committee is hereby established.

(2) The Provincial Transformation Committee comprises of –

(a) the following members of the KwaZulu-Natal Provincial Department of Co-operative Governance and Traditional Affairs:

- (i) the Senior General Manager: Local Government Branch;
 - (ii) the General Manager: Municipal Governance and Administration, who will act as Chairperson of the Provincial Transformation Committee;
 - (iii) the General Manager: Municipal Finance;
 - (iv) the General Manager: Traditional Affairs;
 - (v) the General Manager: Municipal Planning;
 - (vi) the General Manager: Municipal Infrastructure;
 - (vii) the Chief Financial Officer; and
 - (viii) the General Manager: Communications; and
- (b) the General Manager: Budget, KwaZulu-Natal Provincial Treasury;
- (c) two representatives from SALGA KwaZulu-Natal; and
- (d) two Provincial union representatives: one from IMATU and one from SAMWU.

(3) The Provincial Transformation Committee may co-opt or invite such other members or municipal managers to serve on the said committee as it may deem necessary from time to time in order to assist it in the performance of its functions and duties.

(4) The Provincial Transformation Committee may establish subcommittees to attend to any matters: Provided that any decision taken by a subcommittee must be ratified by the Provincial Transformation Committee at its next meeting.

FUNCTIONS OF THE PROVINCIAL TRANSFORMATION COMMITTEE

4.(1) The main functions of the Provincial Transformation Committee are to –

- (a) act as a consultative, advisory and policy making forum for the MEC and affected municipalities concerning the disestablishment and mergers of the affected municipalities in the new municipal areas;
- (b) exercise oversight, support and guide the committees in the restructuring process;
- (c) ratify or amend recommendations made by the committees, before the recommendations are adopted by the respective affected municipal councils;
- (d) act as a dispute resolution body in those instances where municipal councils deviate from the recommendations made in terms of paragraph (c) above: Provided that in the event that the dispute is not resolved within 14 days, the matter must be submitted to the MEC, whose decision will be final and binding on the affected municipalities; and
- (e) to advise the MEC on the legal, practical and other consequences of the restructuring process.

(2) The Provincial Transformation Committee has all the powers necessary for the effective performance of its functions and affected municipalities must co-operate with the said Committee with a view to assist it in the performance of its functions.

(3) Any committee or entity that was appointed or came into being in anticipation of, but prior to the publication of this Notice, is, for all intents and purposes, deemed to be the Provincial Transformation Committee, and to have met and performed any functions contemplated in this Notice, as if it had been established in terms of this Notice.

CONDUCT OF MEMBERS

5.(1) A member of the Provincial Transformation Committee must perform the functions of office –

- (a) in good faith; and
- (b) without fear, favour or prejudice.

(2) A member of the Provincial Transformation Committee may not act in any other way that compromises the credibility, impartiality or integrity of the said Committee.

MEETINGS OF THE PROVINCIAL TRANSFORMATION COMMITTEE

6.(1) The Chairperson of the Provincial Transformation Committee decides where and when the said Committee will meet.

(2) The Chairperson presides at the meetings of the Provincial Transformation Committee: Provided that in the event of the Chairperson being absent from a meeting, the members present must elect another member to preside at the meeting.

(3) A majority of the members of the Provincial Transformation Committee constitutes a quorum for a meeting.

BYLAE

OMSKRYWINGS

1. In hierdie Bylae het 'n woord of uitdrukking, waaraan 'n betekenis in die Wet op Plaaslike Regering: Munisipale Strukture, 1998 (Wet No. 117 van 1998), toegeken is, dieselfde betekenis en, tensy uit die samehang anders blyk, beteken –

“**komitees**” die Munisipale Politieke Veranderingsbestuur en Munisipale Tegniese Verandering Bestuurskomitees, ingestel ingevolge Provinsiale Kennisgewing No. 64 gepubliseer in die KwaZulu-Natal Provinsiale *Koerant* No. 1168 gedateer 26 Junie 2014;

“**LUR**” die KwaZulu-Natal Lid van die Uitvoerende Raad verantwoordelik vir plaaslike regering; en

“**munisipaliteite geraak**” die volgende munisipaliteite wat geraak word deur die herbepaling van grense ingevolge artikel 21 van die Wet op Plaaslike Regering: Munisipale Afbakening, 1998 (Wet No. 27 van 1998), soos uiteengesit in Provinsiale Kennisgewing No. 57 gepubliseer in die KwaZulu-Natal Provinsiale *Koerant* No. 1042 gedateer 23 Oktober 2013:

- (a) Kwa Sani/ Ingwe Plaaslike Munisipaliteite;
- (b) Hlabisa/ Groot Vyf Valsbaai Plaaslike Munisipaliteite;
- (c) Emnambithi/ Ladysmith/ Indaka Plaaslike Munisipaliteite;
- (d) Hibiskuskus/ Ezinqoleni Plaaslike Munisipaliteite;
- (e) Umtshezi/ Imbabazane Plaaslike Munisipaliteite;
- (f) Ntambanana/ Mthonjaneni/ uMhlatuze/ uMfolozi Plaaslike Munisipaliteite; en
- (g) uMdoni/ Vulamehlo/ eThekwin Metro.

OOGMERK VAN OORGANGSMAATREËLS

2. Die oogmerk van die oorgangsmatreëls uiteengesit in hierdie Bylae is die fasilitering van die herstrukturering van die munisipaliteite wat geraak word daardeur.

INSTELLING VAN DIE PROVINSIALE TRANSFORMASIEKOMITEE

3.(1) Hiermee word 'n fasiliteringskomitee, wat die Provinsiale Transformasiekomitee genoem word, ingestel.

(2) Die Provinsiale Transformasiekomitee bestaan uit –

(a) die volgende lede van die KwaZulu-Natal Provinsiale Departement van Samewerkende Regering en Tradisionele Sake:

(i) die Senior Bestuurder: Plaaslike Regeringstak;

(ii) die Algemene Bestuurder: Munisipale Regering en Administrasie, wat as Voorsitter van die Provinsiale Transformasiekomitee sal optree;

(iii) die Algemene Bestuurder: Munisipale Finansies;

(iv) die Algemene Bestuurder: Tradisionele Sake;

(v) die Algemene Bestuurder: Munisipale Beplanning;

(vi) die Algemene Bestuurder: Munisipale Infrastruktuur;

(vii) die Hoof Finansiële Beampte; en

(viii) die Algemene Bestuurder: Kommunikasie; en

(b) die Algemene Bestuurder: Begroting, KwaZulu-Natal Provinsiale Tesourie;

(c) twee verteenwoordigers van SALGA KwaZulu-Natal; en

(d) twee Provinsiale Unieverteenvoerders: een van IMATU en een van SAMWU.

(3) Die Provinsiale Transformasiekomitee kan, soos wat hy van tyd tot tyd nodig mag ag, sodanige ander lede of munisipale bestuurders koöpteer of uitnoui om op die vermelde komitee te dien ten einde hom by te staan in die verrigting van sy werksaamhede en uitvoering van sy pligte.

(4) Die Provinsiale Transformasiekomitee kan subkomitees instel om aandag te skenk aan enige aangeleenthede: Met dien verstande dat enige besluit geneem deur 'n subkomitee bekragtig moet word deur die Provinsiale Transformasiekomitee tydens sy volgende vergadering.

WERKSAAMHEDE VAN DIE PROVINSIALE TRANSFORMASIEKOMITEE

4.(1) Die hoofsaaklike werksaamhede van die Provinsiale Transformasiekomitee is om –

(a) op te tree as raadplegende, raadgewende en beleidmakende forum vir die LUR en munisipaliteite geraak ten opsigte van die ontbinding en samesmelting van geraakte munisipaliteite in die nuwe munisipale areas;

(b) toesig te hou en ondersteuning en leiding te verskaf aan die komitees in die herstruktureringproses;

(c) aanbevelings gemaak deur die komitees te bekragtig of wysig voordat die aanbevelings aangeneem word deur die onderskeie munisipale rade wat geraak word;

(d) as 'n liggaam vir die beslegting van geskille op te tree in gevalle waar munisipale rade afwyk van die aanbevelings gemaak ingevolge paragraaf (c) hierbo: Met dien verstande dat, in die geval dat die dispuut nie besleg word binne 14 dae nie, die aangeleentheid aan die LUR voorgelê moet word, wie se beslissing finaal en bindend sal wees op die munisipaliteite geraak daardeur; en

(e) die LUR te adviseer oor die wetlike, praktiese en ander gevolge van die herstruktureringproses.

(2) Die Provinsiale Transformasiekomitee beskik oor al die bevoegdhede wat nodig word vir die effektiewe verrigting van sy werksaamhede en die geraakte munisipaliteite moet met die vermelde Komitee saamwerk met die oog daarop om hom by te staan in die verrigting van sy funksies.

(3) Enige komitee of entiteit wat aangestel is of tot stand gekom het in afwagting, of voor die publikasie, van hierdie Kennisgewing, word vir alle doeleindes beskou as die Provinsiale Transformasiekomitee asof die komitee of entiteit vergader het en enige werksaamhede verrig het, soos bedoel in hierdie Kennisgewing, asof dit ingestel is ingevolge hierdie Kennisgewing.

GEDRAG VAN LEDE

5.(1) 'n Lid van die Provinsiale Transformasiekomitee moet die werksaamhede van die amp –

(a) te goeder trou; en

(b) sonder vrees, guns of vooroordeel,
verrig.

(2) 'n Lid van die Provinsiale Transformasiekomitee kan nie op enige ander wyse optree wat die geloofwaardigheid, onpartydigheid of integriteit van die vermelde Komitee kompromitteer nie.

VERGADERINGS VAN DIE PROVINSIALE TRANSFORMASIEKOMITEE

6.(1) Die Voorsitter van die Provinsiale Transformasiekomitee besluit wanneer en waar die vermelde Komitee sal vergader.

(2) Die Voorsitter sit voor by die vergaderings van die Provinsiale Transformasiekomitee: Met dien verstande dat in die geval dat die Voorsitter van 'n vergadering afwesig sou wees, die teenwoordige lede 'n ander lid verkies om as voorsitter van die vergadering op te tree.

(3) 'n Meerderheid van die lede van die Provinsiale Transformasiekomitee maak 'n kworum vir 'n vergadering uit.

3.(1) Ikomidi elihlalo elibizwa ngeKomidi elibhekele uGuquko esiFundazweni ngalokhu liyasungulwa.

(2) Ikomidi eliPhethe ezoGuquko esiFundazweni liqukethe –

(a) amalungu oMnyango wezokuBusa ngokuBambisana nezoMdabu esiFundazweni saKwaZulu-Natali:

(i) isikhulu esiphethe abaphathi abakhulu oPhikweni loHulumeni baseKhaya;

(vi) uMphathi oMkhulu obhekele iNgqalasizinda koMasipala;

(vii) isikhulu esibhekele ukuPhathwa kweziMali; kanye

(viii) noMphathi oMkhulu obhekele ezokuXhumana;

(b) uMphathi oMkhulu obhekele iSabelomali eMnyangweni kaMgcinimafa waKwaZulu-Natali

(c) ababili abamele i-SALGA KwaZulu-Natali; kanye

(d) nababili abamele iziNyunyana zabasebenzi esiFundazweni, abavela kwi-IMATU nakwi-SAMWU.

(3) Ikomidi elibhekele uGuquko esiFundazweni lingaqoka noma linganxenxa amanye amalungu noma abaphathi bomasipala ukuba babe abasebenzi abazosiza njengoba ikomidi elikhulu lingabona kudingekile ekwenzeni imisebenzi ethinta ukusebenza kwalo nokufeza amajoka alo.

(4) Ikomidi elibhekele uGuquko esiFundazweni lingasungula amakomidi amancane azolisiza ekubhekaneni nanoma iziphi ezinye izindaba: Kuncike ekutheni noma isiphi isinqumo esithathwe ikomidi elincane kumele siqinisekise iKomidi elibhekele uGuquko esiFundazweni emhlanganweni olandelayo.

IMISEBENZI YEKOMIDI ELIBHEKELE UGUQUKO ESIFUNDAZWENI

4.(1) Izinhlosongqangi zeKomidi elibhekele uGuquko esiFundazweni –
