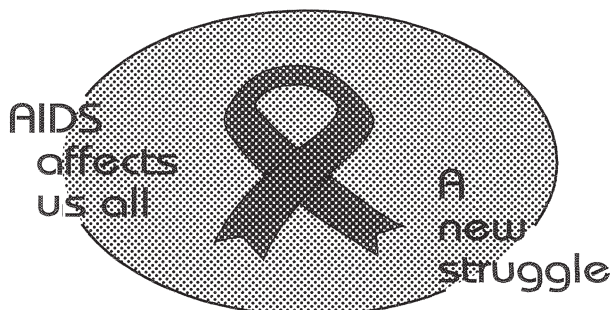

JOINT MUNICIPAL PLANNING TRIBUNAL AND CALL FOR PERSONS TO SERVE ON THE JOINT  
MUNICIPAL PLANNING TRIBUNAL.**

Notice is hereby given in terms of Section 34 of the Act, read with Regulation 7, that the uMgungundlovu District Municipality, together with the Local Municipalities of uMngeni, uMshwathi, Mkhambathini, Richmond, Mporofana and Mpendle, have resolved to establish a Joint Municipal Planning Tribunal (JMPT). The Councils of all the participating municipalities have resolved accordingly, and an Agreement to give effect to the establishment of the JMPT has been entered into, and a copy of the Agreement is available for inspection at the offices of the participating municipalities. Note that development applications must continue to be lodged at the municipality in whose area the proposed development site is situated.

Nominations are hereby invited from members of the public to be appointed to the JMPT for its first term of office. In terms of Section 36(1) of the Act, nominees must have knowledge and experience of spatial planning, land use management and land development or the law related thereto. Nominations must be in writing and must contain the following information:

- The name and address of the nominator, who must be a natural person. Please note that a person may nominate him- or herself.
- The name, address and identity number of the nominee.
- Motivation in support of possible appointment to the Tribunal.
- Curriculum Vitae that will enable the participating municipalities to determine whether the nominee has the knowledge and experience to perform the required functions.
- Certified copies of qualifications and registration certificates with the relevant professional body or voluntary associations.

Note that failure to comply with the above requirements may result in the disqualification of the nomination.
