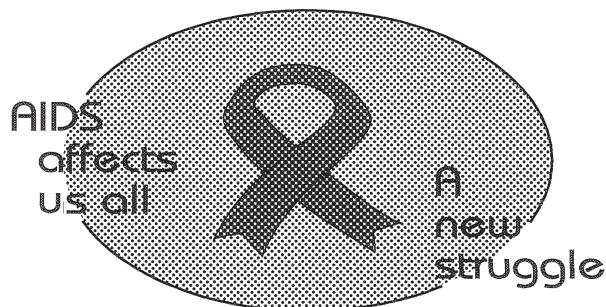

## Notice submission deadlines

Government Printing Works has over the last few months implemented rules for completing and submitting the electronic Adobe Forms when you, the customer, submit your notice request.

In line with these business rules, GPW has revised the notice submission deadlines for all gazettes. Please refer to the GPW website [www.gpwonline.co.za](http://www.gpwonline.co.za) to familiarise yourself with the new deadlines.

### CANCELLATIONS

Don't forget!

Cancellation of notice submissions are accepted by GPW according to the deadlines stated in the table above.

Non-compliance to these deadlines will result in your request being failed. **Please pay special attention to the different deadlines for each gazette.**

**Please note that any notices cancelled after the cancellation deadline will be published and charged at full cost.**

Requests for cancellation must be sent by the original sender of the notice and must accompanied by the relevant notice reference number (N-) in the email body.

### AMENDMENTS TO NOTICES

take note!

With effect **from 01 October**, GPW will not longer accept amendments to notices. The cancellation process will need to be followed and a new notice submitted thereafter for the next available publication date.

### CUSTOMER INQUIRIES

### PROOF OF PAYMENTS

REMINDER

GPW reminds you that all notice submissions **MUST** be submitted with an accompanying proof of payment (PoP) or purchase order (PO). If any PoP's or PO's are received without a notice submission, it will be failed and your notice will not be processed.

When submitting your notice request to [submit.egazette@gpw.gov.za](mailto:submit.egazette@gpw.gov.za), please ensure that a purchase order (GPW Account customer) or proof of payment (non-GPW Account customer) is included with your notice submission. All documentation relating to the notice submission must be in a single email.

A reminder that documents must be attached separately in your email to GPW. (In other words, your email should have an Adobe Form plus proof of payment/purchase order – 2 separate attachments – where notice content is applicable, it should also be a 3rd separate attachment).

### REMINDER OF THE GPW BUSINESS RULES

- Single notice, single email – with proof of payment or purchase order.
- All documents must be attached separately in your email to GPW.
- 1 notice = 1 form, i.e. each notice must be on a separate form
- Please submit your notice **ONLY ONCE**.
- Requests for information, quotations and inquiries must be sent to the Contact Centre **ONLY**.
- The notice information that you send us on the form is what we publish. Please do not put any instructions in the email body.

## EXPRESSION OF INTEREST

The KwaZulu-Natal Nature Conservation Board is the nature conservation agency in the Province of KwaZulu-Natal. Its core disciplines are biodiversity conservation, the creation and management of partnerships with stakeholders and the local communities and the provision of affordable ecotourism destinations within the Province of KwaZulu-Natal.

**BID NO: EKZNW 02/2016****DEVELOP, BUILD AND OPERATE THE ROYAL NATAL NATIONAL PARK HOTEL AND CONFERENCE CENTRE**

The organisation invites expressions of interest from suitably qualified and experienced tourism establishment developers for the development and management of the Royal Natal National Park Hotel and Conference Centre within the Maloti-UKhahlamba Drakensberg World Heritage Park. The service provider will develop (based on a plan developed with EKZNW), build and operate the facility as a partnership arrangement with Ezemvelo. The proposal will, as much as possible, highlight the Park's world heritage status and attempt to resuscitate the themes and features of the old hotel. The project will be to develop the **Royal Natal Lodge's/Hotel's**: • Visitors Centre and Conference Facility • Conference lodge and chalets (to accommodate conference attendees in the event of Thendele overflow) • Restaurant.

Ezemvelo will undertake a competitive bidding exercise and to issue a Request for Proposal (RFP) to those companies who express their interest and provide initial relevant information demonstrating their ability to fulfil Ezemvelo's requirements. Parties will have to prove that a special purpose vehicle (SPV) has been set up for the sole purpose of implementing this project. In addition, the interested companies will be requested to complete an Ezemvelo Vendor Registration Form. A detailed Scope of Works (SOW) will be provided to companies shortlisted for receipt of the RFP documents. Please note that this request for an EOI is not an invitation for submission of a bid.

The tender will be awarded for a fixed period.

**Short-listing criteria:** • A proven track record within the appropriate industry (tourism) • Relevant experience supported by a proven track record in the development of eco-tourism facilities • Willingness and ability to employ and train local community members • Appropriate experience in conducting business within a public resort • Ability to develop a proposal which is in line with the ethos of the Maloti-UKhahlamba World Heritage Park.

**Expressions of interest should include the following:** • An overview of the type of business envisaged • A brief overview of company history (track record) structure and capacity • Necessary acumen and infrastructure and financial model to be used to render the service • Details of relevant experience and expertise.

**Lodges/Cottages:** As part of its Business Development and Sales strategies, Ezemvelo is considering entering into partnership arrangements with the corporate/private sector for the use of its lodge/cottage facilities for a period of five years (or multiples thereof) in exchange for reasonable fees paid on commencement of the contract. The funds will be used to ensure that the facility is maintained and kept in a condition that is suitable to the corporate partner.

**Resorts:** The organisation invites expressions of interest from interested organisations for the use of Ezemvelo's selected eco-tourism resorts which are not core to Ezemvelo's operations. Expressions of interest are invited to develop existing facilities (with the aim of enhancing the infrastructure) and operate for a period not less than five years (or multiples thereof) in line with the capital investment. The organisation will engage in negotiations with selected entities to facilitate the drafting of a contractual arrangement.

**Expressions of interest should include the following:** • Development and operational plans • The intended duration of the contract • Company profile • The intended use for the facility.
