

Government Printing Works Notice submission deadlines

Government Printing Works has over the last few months implemented rules for completing and submitting the electronic Adobe Forms when you, the customer, submit your notice request.

In line with these business rules, GPW has revised the notice submission deadlines for all gazettes. Please refer to the GPW website <u>www.gpwonline.co.za</u> to familiarise yourself with the new deadlines.

CANCELLATIONS

Cancellation of notice submissions are accepted by GPW according to the deadlines stated in the table above. Non-compliance to these deadlines will result in your request being failed. **Please pay special attention to the different deadlines for each gazette**.

Please note that any notices cancelled after the cancellation deadline will be published and charged at full cost.

Requests for cancellation must be sent by the original sender of the notice and must accompanied by the relevant notice reference number (N-) in the email body.

AMENOMENTS TO NOTICES n



With effect from 01 October, GPW will not longer accept amendments to notices. The cancellation process will need to be followed and a new notice submitted thereafter for the next available publication date.

CUSTOMER INQUIRIES

Many of our customers request immediate feedback/confirmation of notice placement in the gazette from our Contact Centre once they have submitted their notice – While GPW deems it one of their highest priorities and responsibilities to provide customers with this requested feedback and the best service at all times, we are only able to do so once we have started processing your notice submission.

GPW has a <u>2-working day turnaround time for processing notices</u> received according to the business rules and deadline submissions.

PROOF OF PAYMENTS REMINDER

GPW reminds you that all notice submissions **MUST** be submitted with an accompanying proof of payment (PoP) or purchase order (PO). If any PoP's or PO's are received without a notice submission, it will be failed and your notice will not be processed.

When submitting your notice request to <u>submit.egazette@gpw.gov.za</u>, please ensure that a purchase order (GPW Account customer) or proof of payment (non-GPW Account customer) is included with your notice submission. All documentation relating to the notice submission must be in a single email.

A reminder that documents must be attached separately in your email to GPW. (In other words, your email should have an Adobe Form plus proof of payment/purchase order – 2 separate attachments – where notice content is applicable, it should also be a 3rd separate attachment).

REMINDER OF THE GPW BUSINESS RULES

- □ Single notice, single email with proof of payment or purchase order.
- All documents must be attached separately in your email to GPW.
- □ 1 notice = 1 form, i.e. each notice must be on a separate form
- Please submit your notice **ONLY ONCE.**
- Requests for information, quotations and inquiries must be sent to the Contact Centre **ONLY**.
- The notice information that you send us on the form is what we publish. Please do not put any instructions in the email body.

NOTICE 13 OF 2016

Notice is hereby given that Applications for Environmental Authorisation in terms of the EIA Regulations, 2014 (Regulations in terms of Chapter 6 of the National Environmental Management Act, 1998, as amended) will be lodged with the KwaZulu-Natal Department of Economic Development, Tourism and Environmental Affairs. A Water Use License Application (WULA) in terms of the National Water Act, 1998 (Act No. 36 of 1998) will also be required.

- The KZN Department of Transport proposes to conduct the upgrade of the **D1252 Road** within the Uthukela District Municipality. The proposed upgrade consists of the installation of four watercourse crossings and the use of two borrows pits to obtain aggregate for the layer works of the road upgrade. Crossing 1: 28°55'56.28"S 29°36'43.68"E, Crossing 2: 28°56'3.12"S 29°36'47.10"E, Crossing 3: 28°56'5.09"S 29°36'44.00"E, Crossing 4: 28°56'15.12"S 29°35'1.08"E, Borrow Pit 1: 28°56'4.20"S 29°35'58.74"E, Borrow Pit: 28°55'46.2

- Ecovate Group propose to develop a green waste energy park at the **Bisasar Road Landfill site** in Durban, Kwazulu Natal. Two site alternatives have been identified. The coordinates for the proposed sites are: Site alternative 1 (preferred): 29°48'59.15"S 30°58'54.32"E. Site alternative 2: 29°48'44.04"S 30°58'57.16"E.

- The KwaZulu-Natal Department of Transport proposes to upgrade a bridge along P164 Main Road within the Mpofana Local and uMgungundlovu Municipalities. TThe new bridge will replace an existing structure which will be demolished once the new bridge is constructed. The coordinates of the proposed bridges are: 29°18'4.28"S 29°57'47.04"E

- The KwaZulu-Natal Department of Transport proposes to upgrade a bridge along P167 Main Road within the Mpofana Local and uMgungundlovu Municipalities. The proposed New Barker's bridge will be constructed across the Klein Mooi River, the coordinates of the proposed bridge are: 29°13'55.40"S 29°55'31.24"E.

- Tongaat Hulett Developments propose to facilitate the construction of mixed-use developments within the Ntshongweni area of the eThekwini Municipality. The central coordinates for the various precincts: Precinct 2: 29°47'33.05"S, 30°45'4.83"E; Precinct 3: 29°48'50.66"S, 30°45'8.31"E. An open day will be held on the 23rd May 2016 at the Shongweni Polo Club from 15:00-18:00.

NOTICE 14 OF 2016

Notice is hereby given that applications for Water Use License Applications (WULA) in terms of the National Water Act, 1998 (Act No. 36 of 1998) will be lodged with the Department of Water and Sanitation (DWS).

- The Department of Transport (DoT) propose the upgrade of **Main Road P77** between kilometer 15 and kilometer 20 to blacktop (asphalt/tar) and include improvements to stormwater drains within the Vulamehlo Local Municipality. The coordinates for the proposed road upgrade are, Start Point: 30°11'43.43"S; 30°34'59.32"E and End Point: 30°10'18.80"S; 30°31'24.18"E.

- The Zululand District Municipality propose to construct a **Water Treatment Works (WTW)** and associated infrastructure in Frischgewaagd which forms part of the eDumbe Local Municipality. The proposed development is proposed due to the lack of potable water within the rural areas of the local municipality. The co-ordinates for the proposed location of the WTW are 27°21'43.67"S; 30°57'26.03"E.

- The iLembe District Municipality is proposing to implement an alternative **ground and surface bulk water supply** augmentation program in the Masibambisane, KwaDukuza and Ndwedwe areas. The co-ordinates for the sites are: **Masibambisane**: iMvutshane River Abstraction: 29°8'47.69"S & 31°1'55.18"E & Mpumulo Hospital WTW: 29°8'39.48"S & 31°2'6.20"E; **KwaDukuza**: Umvoti1: 29°20'47.83"S & 31°15'22.90"E, Umvoti2: 29°20'52.30"S & 31°15'12.24"E, Umvoti3: 29°21'8.93"S & 31°16'29.60"E, Umvoti4: 29°19'59.70"S & 31°15'31.97"E, Umvoti6: 29°19'27.66"S & 31°15'53.93"E, Umvoti7: 29°20'8.23"S & 31°16'29.60"E, Umvoti8: 29°18'42.37"S & 31°16'50.59"E, Umvoti9: 29°18'31.86"S & 31°17'52.98"E, Umvoti10: 29°19'18.16"S & 31°18'0.00"E; and **Ndwedwe:** DT#1-Ndwe: 29°32'11.90"S & 31°1'17.90"E, DT#2-Ndwe: 29°31'26.18"S & 31°2'17.59"E, DT#3-Ndwe: 29°31'42.57"S & 31°2'46.96"E, DT#4-Ndwe: 29°31'0.70"S & 31°1'36.80"E, DT#5-Ndwe: 29°30'0.27"S & 31°1'59.79"E, DT#5-Ndweold: 29°33'42.48"S & 30°54'11.52"E, DT#11-Ndwe: 29°25'49.41"S & 30°52'7.64"E, DT#12-Ndwe: 29°28'44.36"S & 30°57'58.74"E, DT#13- Ndwe: 29°31'6.02"S & 30°57'38.87"E

The WULA is required in terms of Section 21 of the National Water Act, 1998 (Act 36 of 1998) (NWA) for the following water uses: Section 21(a) - taking water from a water resource and Section 21(b)- storing water; Section 21(c)- impeding or diverting the flow of water in a watercourse and Section 21(i)- altering the bed, banks, course of characteristics of a water course.

The above-mentioned proposed developments require applications subject to an EIA and WULA. In terms of the WULA the following water uses may be required: Section 21(a), Section 21(b), Section 21(c) & Section 21(i). All interested and affected parties (I&APs) are invited to register with the contact person below. All registered I&APs will be allowed 60days to comment on the WULA and 30days on the EIA upon release of the documentation. Representations with respect to this application may be made by phone, fax or e-mail. Please note that in order to continue to receive information regarding this project, you must register as an I&AP.
