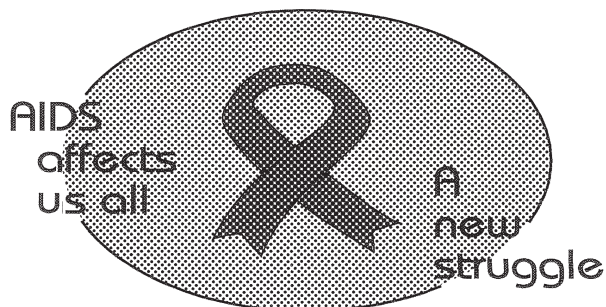

GOVERNMENT PRINTING WORKS - BUSINESS RULES

GOVERNMENT PRINTING WORKS - BUSINESS RULES**NOTICE SUBMISSION PROCESS**

3. Download the latest *Adobe* form, for the relevant notice to be placed, from the **Government Printing Works** website www.gpwonline.co.za.
4. The *Adobe* form needs to be completed electronically using *Adobe Acrobat / Acrobat Reader*. Only electronically completed *Adobe* forms will be accepted. No printed, handwritten and/or scanned *Adobe* forms will be accepted.
5. The completed electronic *Adobe* form has to be submitted via email to submit.egazette@gpw.gov.za. The form needs to be submitted in its original electronic *Adobe* format to enable the system to extract the completed information from the form for placement in the publication.
6. Each notice submission should be sent as a single email. The email should contain **all documentation relating to a particular notice submission**, each as a separate attachment:
 - 6.1. Electronically completed *Adobe* form, specific to the type of notice that is to be placed.
 - 6.1.1. For National *Government Gazette* or *Provincial Gazette* notices, the notices must be accompanied by an electronic Z95 or Z95Prov *Adobe* form
 - 6.1.2. The notice content (body copy) **MUST** be a separate attachment.
 - 6.2. Proof of Payment / Purchase Order: **Government Printing Works** account customer must include a copy of their Purchase Order. **Non-Government Printing Works** account customer needs to submit the proof of payment for the notice
 - 6.3. Where separate notice content is applicable (Z95, Z95 Prov and TForm 3, it should also be attached as a separate attachment. (See specifications below, point 11).

7. The electronic *Adobe* form will be taken as the primary source for the notice information to be published. 8. To avoid duplicated publication of the same notice and double billing, Please submit your notice **ONLY ONCE**.
9. Notices brought to **GPW** by "walk-in" customers on electronic media can only be submitted in *Adobe* electronic form format. All "walk-in" customers with notices that are not on electronic *Adobe* forms will be routed to the Contact Centre where they will be assisted to complete the forms in the required format.
10. Should a customer submit a bulk submission of hard copy notices delivered by a messenger on behalf of any organisation e.g. newspaper publisher, the messenger will be referred back to the sender as the submission does not adhere to the submission rules.

11. Where the copy is part of a separate attachment document for Z95, Z95Prov and TForm03
 - 11.1. Copy of notices must be supplied in a separate document and may not constitute part of any covering letter, purchase order, proof of payment or other attached documents.

The content document should contain only one notice. (You may include the different translations of the same notice in the same document).
 - 11.2. The notice should be set on an A4 page, with margins and fonts set as follows:

Page size = A4 Portrait with page margins: Top = 40mm, LH/RH = 16mm, Bottom = 40mm;
Use font size: Arial or Helvetica 10pt with 11pt line spacing;

Page size = A4 Landscape with page margins: Top = 16mm, LH/RH = 40mm, Bottom = 16mm;
Use font size: Arial or Helvetica 10pt with 11pt line spacing;

CANCELLATIONS

12. Cancellation of notice submissions are accepted by **GPW** according to the deadlines stated in the table above in point 2. Non-compliance to these deadlines will result in your request being failed. Please pay special attention to the different deadlines for each gazette. Please note that any notices cancelled after the cancellation deadline will be published and charged at full cost.
13. Requests for cancellation must be sent by the original sender of the notice and must be accompanied by the relevant notice reference number (N-) in the email body.

AMENDMENTS TO NOTICES

14. With effect from 01 October 2015, **GPW** will not longer accept amendments to notices. The cancellation process will need to be followed according to the deadline and a new notice submitted thereafter for the next available publication date.

REJECTIONS

15. All notices not meeting the submission rules will be rejected to the customer to be corrected and resubmitted. Reasons for rejections include the following:

16. Any notices other than legal notices are subject to the approval of the Government Printer, who may refuse acceptance or further publication of any notice.

The copy of notice in layout format (previously known as proof-out) is only provided where requested, for Advertiser to see the notice in final Gazette layout. Should they find that the information submitted was incorrect, they should request for a notice cancellation and resubmit the corrected notice, subject to standard submission deadlines. The cancellation is also subject to the stages in the publishing process, i.e. If cancellation is received when production (printing process) has commenced, then the notice cannot be cancelled.

MUNICIPAL NOTICE 111 OF 2016**CITY OF uMHLATHUZE****PUBLIC NOTICE****AMENDMENT TO THE BYLAWS RELATING TO THE STANDING ORDERS FOR COUNCIL AND ITS COMMITTEES**

The uMhlathuze Municipality has, in terms of Section 156 of the Constitution, 1996 (Act No 108 of 1996) read in conjunction with section 12(3) of the Local Government: Municipal Systems Act, 2000 (Act No 32 of 2000), passed a resolution for the amendment of the Bylaws Relating to the Standing Orders for Council and its Committees. The following are the applicable amendments to the Bylaws relating to the Standing Orders for Council and its Committees as promulgated in the Provincial Gazette Number 6082 under Notice Number 4 dated 31 January 2003, which shall come into operation on the date of publication hereof:

Clause 35 that makes provision for a removal or exclusion/suspension of a member(s) be amended and to read as follows:

“35.1 If a member refuses to comply with a direction in terms of section 34 the Speaker/Chairperson may direct a security personnel who provide security services to Council to remove the member or to cause his/her removal and to take steps to prevent his return to the meeting.

35.2 The Speaker/Chairman may exclude/suspend from meetings of the Council for such period as it may determine, a member who so misconducted himself / herself, or behaved in an unseemly manner or who wilfully disregards the authority of the chair or who wilfully and persistently obstructs the business at any meeting: Provided that such suspension/exclusion shall not equal or exceed such period as would result in the vacation of such member’s office in terms of section 4(2) of the Code of Conduct for Councillors (refer section 1 “Definitions”).

35.3 Subject to clause 35.2, a proposal to exclude/suspend any person may be moved at any stage of the meeting by any member of Council.

35.4”

2. Clause 35.5 to be inserted and to read as follows:

“35.5 The suspension of a member shall on the first occasion during a session continue for 5 Council working days, on the second occasion for 10 Council working days, and on any subsequent occasion for 20 Council working days without pay in all three instances;”

3. Clause 35.6 to be inserted and to read as follows:

“35.6 Any person who continuously displays this behaviour will be dealt with in terms of the Code of Conduct for Councillors”.

4. Clause 36 to be added with the sub-heading to read “Expression of regret” and to read:

“36.1 A member of this Council who has been suspended or named may submit to the Speaker a written expression of regret, and if the Speaker approves such expression of regret, he or she may discharge the suspension or permit the member to take his or her seat, and the Speaker shall inform this Council accordingly.”
