1. The Member of the KwaZulu-Natal Executive Council responsible for Co-operative Governance and Traditional Affairs, in her capacity as the Member of the Executive Council responsible for local government, under the powers vested in her by section 16(1)(d) of the Local Government Municipal Structures Act, 1998 (Act No. 117 of 1998), to amend notices issued in terms of section 12 of the said Act, and in order to give effect to a decision by the Municipal Council of the Mtubatuba Local Municipality to designate the Whip and Chairperson of Municipal Public Accounts Committee as full-time Councillors, proposes to publish the following notice:

“I, Nomusa Dube-Ncube, Member of the KwaZulu-Natal Executive Council responsible for local government, under powers vested in me by section 16(1)(d) read with section 18(4) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), hereby determine that the Mtubatuba Local Municipality may designate the Whip and Chairperson of Municipal Public Accounts Committee as full-time Councillors.”
