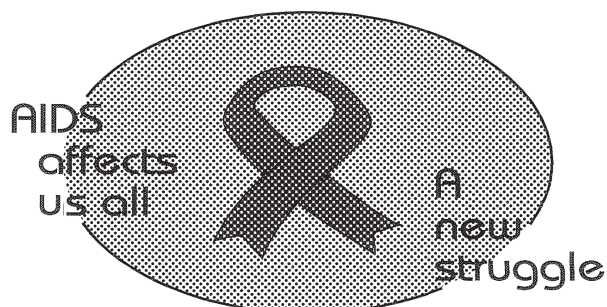

PROVINCIAL NOTICE 27 OF 2017**DEPARTMENT OF COOPERATIVE GOVERNANCE AND TRADITIONAL AFFAIRS****NOTICE IN TERMS OF SECTION 35 OF THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998, READ WITH SECTION 139(1)(c) OF THE CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1996 – APPOINTMENT OF ADMINISTRATOR OF THE NQUTHU LOCAL MUNICIPALITY AND DETERMINATION OF THE POWERS AND FUNCTIONS OF THE ADMINISTRATOR**

I, Nomusa Dube-Ncube, in my capacity as Member of the KwaZulu-Natal Executive Council responsible for local government, subsequent to a decision of the KwaZulu-Natal Executive Council on 8 February 2017, to dissolve the Nquthu Local Municipal Council in terms of section 139(1)(c) of the Constitution of the Republic of South Africa, 1996, hereby–

(a) under powers vested in me by section 35(1) of the Local Government: Municipal Structures Act, 1998 (Act No. 117 of 1998), appoint Mr. Dumisani Vilakazi as the Administrator of the Nquthu Local Municipality (“the Municipality”), with effect from 24 February 2017; and

(b) in accordance with the provisions of section 35(2) of the Local Government: Municipal Structures Act, 1998, determine that the Administrator must exercise and perform the following powers and functions:

(i) undertake all executive functions of a municipal council except the legislative functions as outlined in section 160(2) of the Constitution, such as the approval of by-laws, the approval of the municipal budget and the imposition of rates, taxes, levies, duties, service fees and surcharges on fees;

(ii) undertake all statutory executive functions of the Mayor;

(iii) undertake all fiscal and financial management functions at the municipality, including being signatory on the municipal primary banking account;

(iv) undertake all steps of section 54A and section 56 of the Local Government: Municipal Systems Act, 2000 (Act No. 32 of 2000), including the removal of acting senior managers where applicable;

(v) undertake the functions referred to in section 67(1)(h) and Schedule 2 of the Local Government: Municipal Systems Act, 2000, read with any other relevant legislative provisions dealing with disciplinary matters, including criminal and civil action;

(vi) implement all governance systems and procedures including oversight over the administration;

(vii) ensure implementation of financial systems, policies and procedures;

(viii) approve all decisions taken by the Municipal Manager or Acting Municipal Manager and section 56 Managers in terms of delegated or original authority;

(ix) revise the turn-around strategy for the Municipality;

(x) implement a system to control and approve all expenditure;

(xi) ensure implementation of the Local Government: Municipal Property Rates Act, 2004 (Act No. 6 of 2004), including preparing the municipal valuation roll in terms of section 32(3) of the said Act where applicable;

(xii) set out a specific strategy for addressing the financial problems experienced by the Municipality, including a strategy for reducing unnecessary expenditure and increasing the collection of revenue;

(xiii) review the organisational structure of the Municipality; and

(xiv) co-ordinate a programme of visits by all KwaZulu-Natal Members of the Executive Council and Provincial Government Departments at the Municipality in order to fast-track service delivery and prepare progress reports in this respect.
