**GENERAL**

1. Rates will be payable monthly in ten (10) equal installments with the first installment payable on 30 September 2017 and the last installment payable on 30 June 2018.

2. The final date for payment of Annual rates will be 28 February 2018.
3. The date on which the determination of rates come into operation is 1 July 2017.
4. Any arrear rates will be subject to legal action as per the municipality's Debt Collection and Credit Control Policy.
5. Any rates that are not paid on the due date will be subject to interest at the rate of 1.25% per month or part thereof.
6. A collection fee of 10% will be raised on the amount outstanding as at 01 May 2018 for annual rates and 1 June 2018 for monthly rates.
7. The date on which the notice was first displayed on the Municipal Notice Board is 1st June 2017.
