To amend the KwaSani Municipality Planning and Land Use Management By-law, 2015, so as to substitute the expression "KwaSani Municipality" of the expression "Dr Nkosazana Dlamini Zuma Municipality" and to amend the name of the By-law

**Amendment of section 128 of the KwaSani Municipality Planning and Land Use Management By-law**

1. Section 128 of the principal By-law is hereby amended by the substitution for section 128 of the following section:

128. This By-law is called the **[KwaSani Municipality] Dr Nkosazana Dlamini Zuma Municipality Spatial Planning and Land Use Management By-law, [2015] 2016**, and comes into operation on the date of this gazette.

**Substitution of certain expressions of the KwaSani Municipality Planning and Land Use Management By-law**

2. The principal By-law is hereby amended by the substitution for the expression "KwaSani Municipality", wherever it occurs, of the expression "Dr Nkosazana Dlamini Zuma Municipality".

**Short title and commencement**

3. This By-law is called the KwaSani Municipality Planning and Land Use Management Amendment By-law, 2017.
