Notice is hereby given in terms of Section 49(1)(a)(i) read together with Section 78(2) of the Local Government Municipal Property Rates Act, 2004 (Act No. 6 of 2004), herein referred to as the “Act”, that the 1st Supplementary Valuation Roll for the financial year 2019-2024 is open for public inspection at our website <http://www.ulundi.gov.za> and Council offices (Finance Department Office) from 22 May 2020 to 25 June 2020.

In terms of Section 50 of the said Act, any owner of property or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from, the Property Valuation Roll must do so in the prescribed forms.

The prescribed forms can be requested from smanqele@ulundi.gov.za or obtainable at the Municipal Finance Department offices. The completed objection forms must be returned **by hand** to the Municipal Offices, BA 131 corner Princess Magogo and King Zwelithini Street, Ulundi or by email to smanqele@ulundi.gov.za.
