I, Nomusa Dube-Ncube, in my capacity as Member of the KwaZulu-Natal Executive Council for Economic Development, Tourism and Environmental Affairs, and in terms of section 33(1) of the National Environmental Management: Protected Areas Act, 2003 (Act No. 57 of 2003) hereby –

- (1) give notice of my intention to declare the properties described in the Schedule hereunder, as a Nature Reserve as contemplated in terms of section 23(1) of the National Environmental Management: Protected Areas Act, 2003, to be named the Umevane Nature Reserve; and
- (2) invite members of the public to submit written representations on, or objections to, the proposed declaration of the above-mentioned Umevane Nature Reserve, as well as any comments on the draft Management Plan of the Umevane Nature Reserve, within 60 days of the publication of this notice: Provided that –

(a) the Draft Management Plan may be viewed at the Offices of Ezemvelo KZN Wildlife at Queen Elizabeth Park, Pietermaritzburg, 3201, or on <http://www.kznwildlife.com/stewardship.html>; and

(b) written submissions must be lodged:

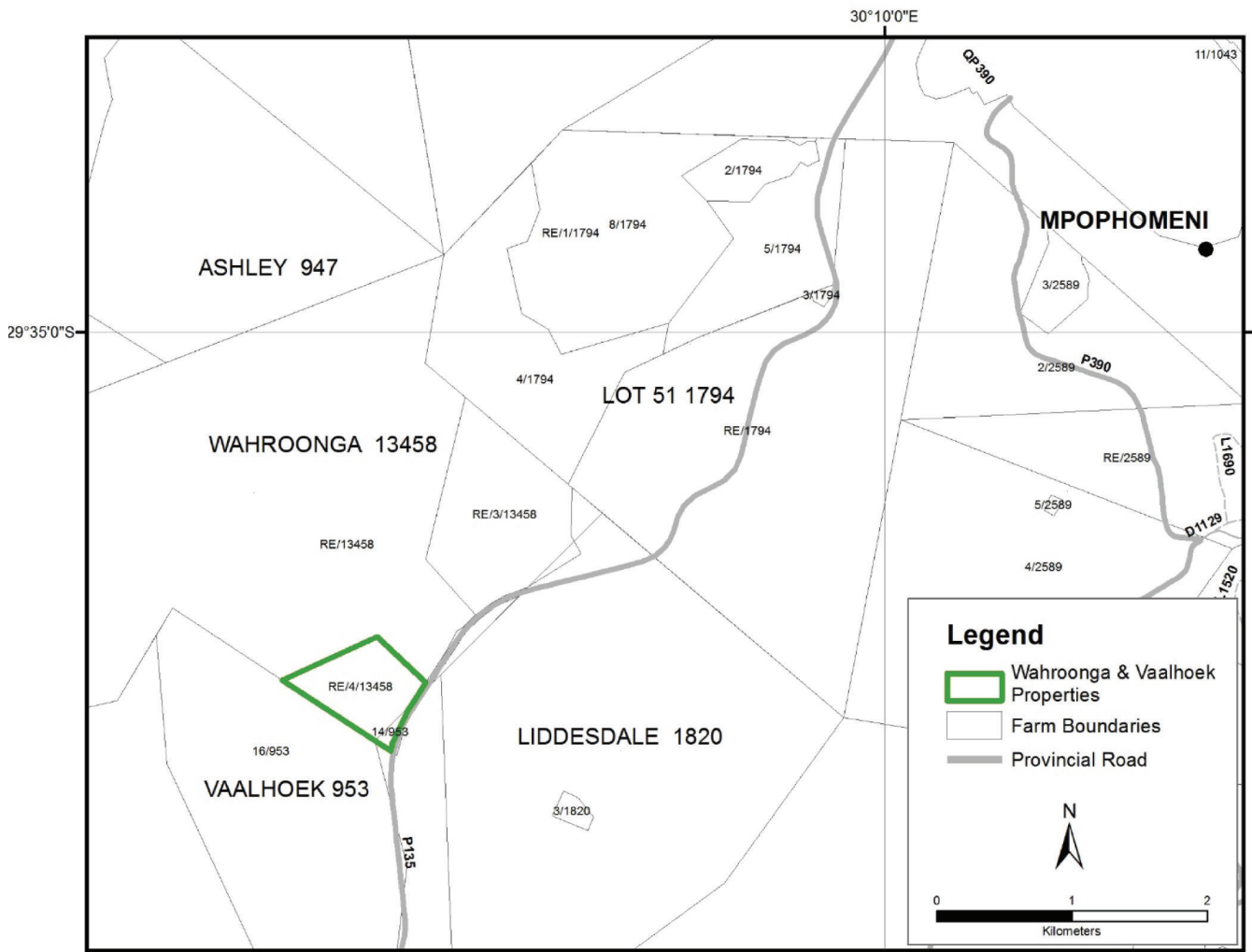

- (b) Remainder of Portion 14 (of 3) of the Farm Vaal Hoek Number 953, Umngeni Municipal area Province, of Kwazulu-Natal, in extent: 1,9919 (One Comma Nine Nine One Nine) Hectares, Deed of Transfer Number T6834/1954 and held by Deed of Transfer Number T12474/1966.
