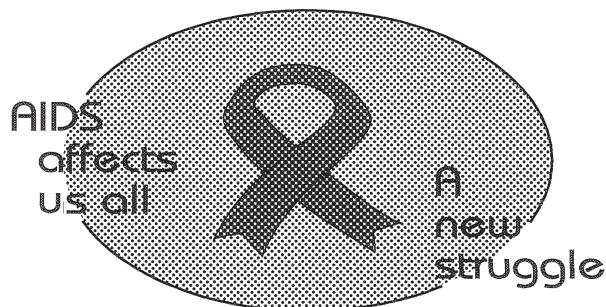

I, Nomusa Dube-Ncube, in my capacity as Member of the KwaZulu-Natal Executive Council for Economic Development, Tourism and Environmental Affairs, and in terms of section 33(1) of the National Environmental Management: Protected Areas Act, 2003 (Act No. 57 of 2003) hereby –

- (1) give notice of my intention to declare the properties described in the Schedule hereunder, as a Nature Reserve as contemplated in terms of section 23(1) of the National Environmental Management: Protected Areas Act, 2003, to be named the Thule Nature Reserve; and
- (2) invite members of the public to submit written representations on, or objections to, the proposed declaration of the above-mentioned Thule Nature Reserve, as well as any comments on the draft Management Plan of the Thule Nature Reserve, within 60 days of the publication of this notice:

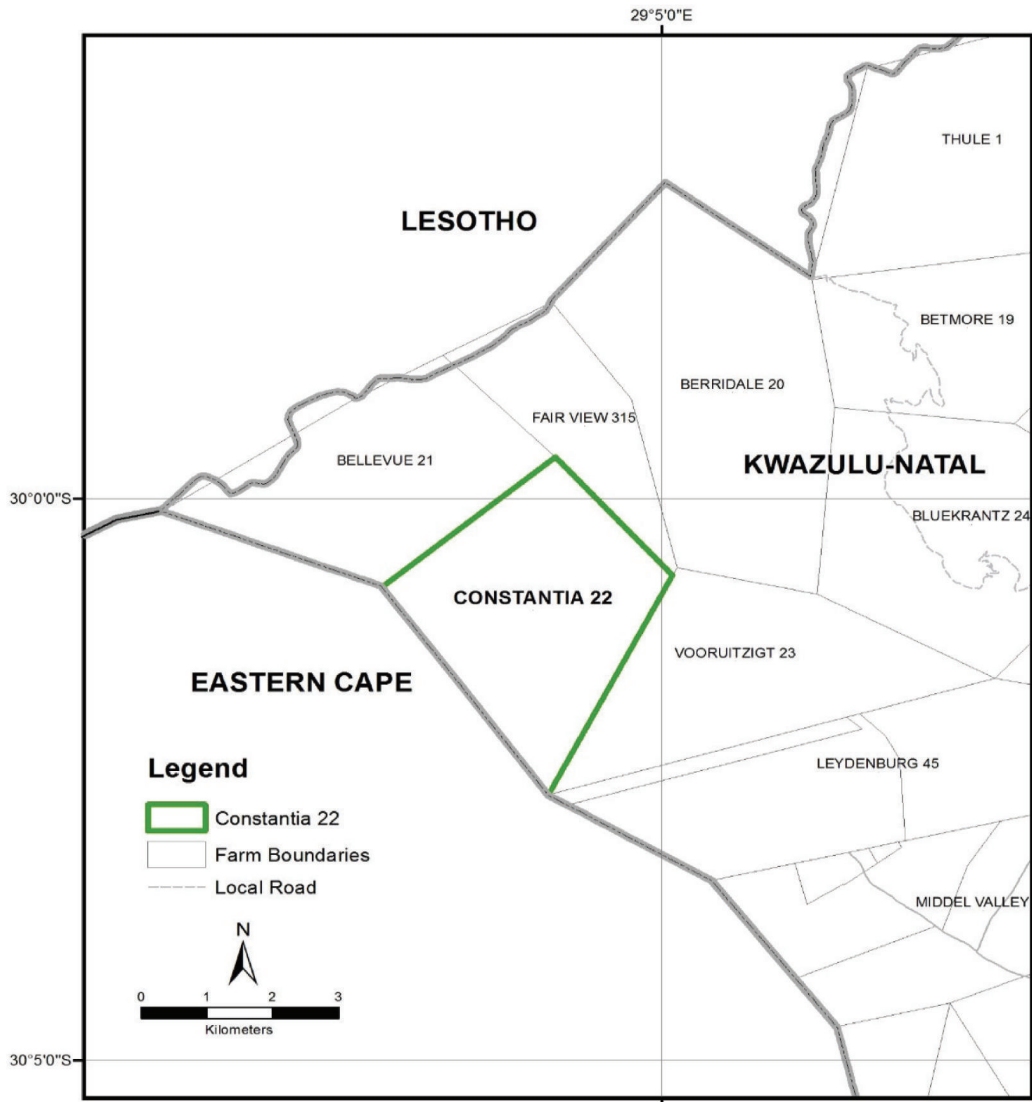
