An invitation is hereby made in terms of Section 49 (1) (a) (ii), that any owner of the property or other person who so desires should lodge an objection with the Municipal Manager in respect of any matter, including the category, reflected in or omitted from the valuation roll within the about mentioned period. Attention is specifically drawn to the fact that in terms of section 50 (2) of the Act, an objection must be in relation to a specific individual property and not against the valuation roll as such.

Due COVID-19 regulations, the valuation roll will be available for physical inspection under strict COVID- 19 protocols. The valuation roll is also accessible on the municipality's website.
