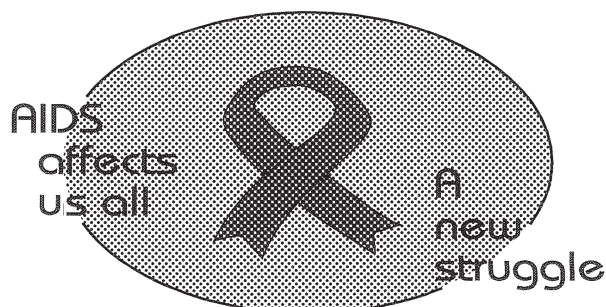

 - (x) Mduduzi Mbokazi- Legal Advisor
- (b) That the remuneration rate for external members be in accordance with the effective guideline on the remuneration of non-official members adopted by the National Treasury.
- (c) That the subsequent review be done on an annual basis based on the guideline on the remuneration of non-official members done by the National Treasury.
- (d) That the external members be excluded from the National Treasury database of government employees.
- (e) That the travel allowance be as per the monthly rates determined by the Department of Transport in accordance with the fluctuation of the price of fuel and to be used by all individuals making use of their own motor vehicle transport.

- (f) That the external members be authorized to claim data costs limited to R300 per month for all virtual meetings.
- (g) That the appointment be published in one of the local newspapers circulating in the municipal area as well as in the provincial gazette;
- (h) That the following resolutions (d), (f) and (g) taken by Full Council at its meeting held on the 24th of June 2015 be rescinded:-

“(d) That the Manager: Economic Development be the Chairperson of the Municipal Planning Tribunal.

(f) That the Manager: Forwarding and Planning and Development Management (who is registered as a Professional Town Planner as per Planning Profession Act) be appointed as the authorized official approving category 2 applications in terms of Schedule 5 of the Spatial Planning and Land Use Management Act Regulations

(g) That the Executive Committee be appointed as the appeals body, as Spatial Planning and Land Use Management Act default position.”
