

Farm Location and GPS Coordinates	The farm is located at uMngeni Local Municipality in Lions River. To reach the property, travel north along the N3 past Midmar Dam and take exit 107 (Howick (north)/Tweedie). Turn left and travel ±1.3 kilometres. Turn right at the T-Junction and travel for ±5.10 kilometres. Turn left onto the Dargle/Impendle Road (just before the "Piggly Wiggly" commercial complex). Travel for ±500.00 metres after which the farm will be on your left.

The properties are suitable for various land use. Prospective farmers interested in leasing properties from the state are encouraged to apply.

ELIGIBILITY CRITERIA

- Applicants must be Africans, Indians and Coloureds, who are South African citizens. The African in this context includes persons from the first nations of South Africa
- Applicants must be 18 years or older and have a valid South African bar-coded Identity document.
- The target groups for the farm is Women, Youth and People living with disabilities.
- · Applicants must indicate their current farming area e.g communal or commonage, if any.
- The successful applicant must be willing to stay fulltime on the farm for the duration of the lease contract.
- Applicants must indicate the farming resources they have or submit proof of access to resources for the farming operation as own contribution; i.e. capital, equipment, biological assets, etc.

MANDATORY DOCUMENTS and PROCEDURES.

- · Completion of the application form.
- In the case of a natural person: Certified copy of the applicant's barcoded South African ID.
- In the case of a juristic person: Unabridged Legal entity registration certificate and a Resolution appointing the representative.
- Signed declaration form indicating that the applicant is not a public servant or a public office bearer.
- Applicants are expected to attend compulsory farm orientation which will be held on the farm on the 1st December at 10:00.
- The applicants who previously attended the compulsory farm orientation of this farm need to attend.
- If shortlisted, you will be required to avail your assets and all the equipment for the purpose of verification.

Government employees and politicians holding public office do not qualify.

Manual Application forms may be obtained from the nearest office of the Department of Agriculture, Land Reform and Rural development OR via email from jabulile.sokhela@drdlr.gov.za.

The application accompanied by business proposals must be hand delivered to the Departmental offices at 199 Pietermaritz Street, 3rd Floor Legalwise Building, Pietermaritzburg KwaZulu-Natal no later than 17 December 2021 at 16:00.

All applications must be hand-delivered, and applications received after the closing date will not be considered. Applicants who previously applied are encouraged to re-apply.

Special COVID 19 Provisions

To adhere to the COVID 19 regulations, the following rules shall apply:

- All compulsory farm orientations will be arranged in phases in order to comply with the
 prescribed numbers in terms of the Disaster Management Act Regulations. The office will
 telephonically inform each applicant of the relevant time slot applicable to them, i.e morning or
 afternoon session in order to avoid overcrowding.
- All applicants must wear facemasks.
- · Social distancing will be observed during the farm inspection.
- Applicants to note that there will be a full screening on the day of the inspection.

SCHEDULE

Amendment to Schedule 2

1. Item 2 of Schedule 2 to the Act is amended by the substitution for item 2 of the following item:

"2. Licence fees.

The licence fees and annual renewal fees payable to the Board[,] in terms of the provisions of sections 75, 76, 89, 94 and 110 of the Act, are as prescribed in the tables hereunder[, which fees are payable to the Board]. Provided that -

(a) in the event that a licence is not renewed by the Board, any fees already paid in respect of such renewal must be refunded to the applicant by the Board; and

(b) a licensee may, with the consent of the Board, make suitable arrangements for the payment of fees, including the deferral of such fees for a period not exceeding 12 months:".

Short Title

2. This Notice is called the First Amendment to Schedule 2 to the KwaZulu-Natal Gaming and Betting Act, 2010.
