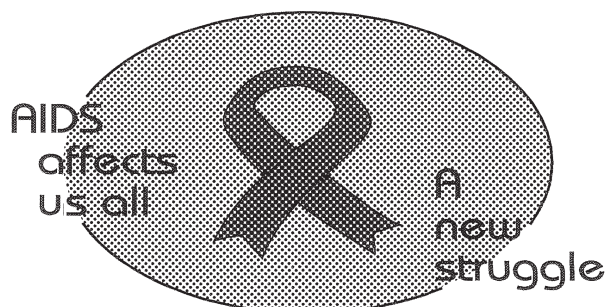

ACT

To amend the KwaZulu-Natal Elimination and Prevention of Re-emergence of Slums Act, 2007, so as to repeal section 16; and to provide for matters connected therewith.

BE IT ENACTED by the Provincial Legislature of the Province of KwaZulu-Natal, as follows:-

Repeal of section 16 of Act 6 of 2007

1. Section 16 of the KwaZulu-Natal Elimination and Prevention of Re-emergence of Slums Act, 2007 (Act No. 6 of 2007), is hereby repealed.

Short title

2. This Act is called the KwaZulu-Natal Elimination and Prevention of Re-emergence of Slums Amendment Act, 2021
