NOTICE TO APPOINT ALL LISTED LOCAL MUNICIPALITIES AS LICENSING AUTHORITIES IN TERMS OF SECTION 2 OF THE NORTH WEST BUSINESS ACT, 1997 Act no.60 OF 1997

WHEREAS I, Darkey Ephraim Africa, as a Member of the Executive Council responsible for Economic Development and Tourism in the North West Province, is responsible for the implementation of the North West Business Act, 1997 (Act No.63 of 1997),

AND WHEREAS in terms section 2(1) (a) of the said Act, and in my capacity as the Responsible Member, may designate a local authority, person or body, to undertake the licensing of a business for a specified area of jurisdiction within the province,

AND WHEREAS such business licenses that would have been issued, would be deemed to have been duly issued in terms of the said North West Business Act, and that the authority which issued such business licenses shall also be deemed to have been duly authorized to issue such licenses in terms of this Act,

AND THAT as from the date of publication of this General Notice, no other authority shall issue a business license to any local businesses falling within the specified jurisdiction of the local authority so authorized.

NOW, THEREFORE, by virtue of the powers vested in me in terms of section 2 of the North West Business Act, 1997, I Darkey Ephraim Africa, hereby appoint the Local Authorities mentioned hereunder, as the licensing authority from the date of the promulgation of the North West Business Act to issue and manage the business licenses of all the businesses falling within the area of jurisdiction of such local authorities within the North West Province.

The names of the Local Authorities that shall be authorized to issue business licenses in accordance with the provisions and regulations of the North West Business Act, 1997, will be the following:

1. Mafikeng Local Municipality
2. Matlosana Local Municipality
3. Kgetleng Local Municipality
4. Madibeng Local Municipality
5. Molopo Local Municipality
6. Maquassi Hills Local Municipality
7. Rustenburg Local Municipality
8. Moses Kotane Local Municipality
