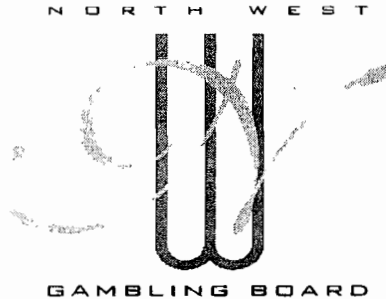

### NOTICE IN TERMS OF SECTION 35 OF THE NORTH WEST GAMBLING ACT, 2001
