### NOTICE 388 OF 2009

#### NORTH WEST DIRECTORATE OF ENTREPRENEURIAL DEVELOPMENT IN NATURAL RESOURCES REPEAL BILL 2009

To provide for the repeal of the North West Directorate of Entrepreneurial Development in Natural Resources Act, 2003; to provide for the disposal of assets under control of the Directorate of Entrepreneurial Development in Natural Resources, and to provide for matters connected therewith.

#### ARRANGEMENT OF SECTIONS

**BE IT ENACTED** by the Legislature of the North West Province as follows:

**1 Definitions** – in this Act, unless the context indicates otherwise:

“**The Act**” means the North West Directorate of Entrepreneurial Development in Natural Resources Act, 2003;

“**Department**” means the Department of Agriculture, Conservation, Environment and Rural Development in the North West Province;

**"Financial Manual"** means Treasury instructions and policies governing disposal of state assets;

**"Public Finance Management Act "** means the Public Finance Management Act 1999 [Act No 1 of 1999] including the Regulations promulgated pursuant thereto.

## 2 Repeal of the Act

The North West Directorate of Entrepreneurial Development in Natural Resources Act, 2003 is hereby repealed.

## 3 Legal Succession

The Department of Agriculture, Conservation, Environment and Rural Development shall be the legal successor to all assets, transactions, agreements, contracts and proceedings which prior to the commencement of this Act were acquired, concluded brought or performed by virtue of the existence of the Directorate of Entrepreneurial Development in Natural Resources Act 2003.

## 4 Disposal of Assets

Any assets which accrue to the Department in terms of section (3) above shall be disposed of in a manner consistent with the provisions of the Public Finance Management Act and the financial manual regulating disposal of state assets.

## 5 Short Title and Commencement.

This Act is called the North West Directorate of Entrepreneurial Development in Natural Resources Repeal Act, 2009 and shall come into effect on the date of its publication in the government gazette.
