Detailed motivation letters from organization making nominations, Curriculum Vitae and letters of acceptance from nominees must be forwarded to the office of the Premier at the address mentioned below.

The nominated person should be a South African resident of no less than 18 years and must be a resident of or conducting business in the North West Province.

Only one nomination will be allowed.

The council will: *Advice Government on HIV and AIDS and related matters; *Guide and monitor activities of District and Local AIDS Councils; *Monitor and co-ordinate implementation programmes and strategies of the provincial multi-sectoral responses to the epidemic; *Provide overall guidance on the implementation of the national HIV and AIDS strategic plan and other related matters; *Mobile resources for the implementation of HIV and AIDS programmes and strategies in the Province at community level; and *Recommend appropriate research around HIV and AIDS.
