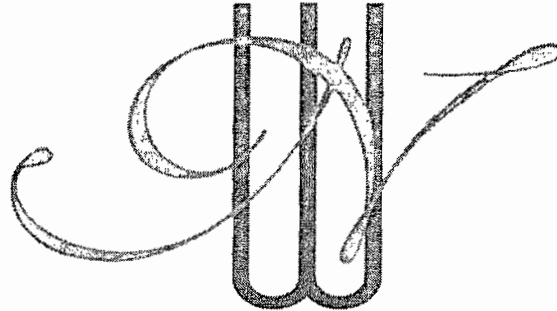

**NOTICE IN TERMS OF SECTION 29 OF THE NORTH WEST GAMBLING ACT:
APPLICATION FOR TRANSFER OF BOOKMAKER LICENCES: PHUMELELA GAMING AND LEISURE
LIMITED**

Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended ("the Act"), that the North West Gambling Board ("the Board") received an application from Phumelela Gaming and Leisure Limited for the transfer of its two (2) Bookmaker licences to Betting World (Proprietary) Limited. Section 44(1) of the Act provides that a holder of a gambling licence may at any time apply to the Board for the transfer of such a licence to a prospective transferee.

Phumelela Gaming and Leisure Limited is licensed by the Board to conduct two (2) Bookmaker operations at **Shop No. 34 and 35, Sun Village Shopping Complex, Sun City Resort and at Corner Nelson Mandela Drive and Berg Street, Rustenburg, respectively.**

Please take note that this application will lie for public inspection or viewing for a period of thirty (30) days from the date of publication of this notice at the offices of the Board, 23 First Street, Industrial Site, Mahikeng between 08h30 – 16h30.

Persons wishing to make representations, comments or objections, in relation to this application submitted to the Board by Phumelela Gaming and Leisure Limited, shall do so in writing and such representations, comments or objections shall contain the following information:

- a) The grounds upon which representations, comments or objections are made;
