constituted within 21 days from the publication of this notice. The Board will have its functions amongst others as to:

- a) Advise me and/or furnish a report or recommendations to me on any matter arising from the application of the Liquor Act No 27 of 1989 or relating to the distribution or control over the distribution of liquor in the Province,
- b) Perform such other functions as may be assigned to the Board in terms of the Act as quoted.
