A NOTICE ON THE PAYMENT OF LIQUOR LICENSE FEES ISSUED BY THE NORTH WEST PROVINCE

Regulation 116(1) of the Liquor Act No 27 of 1989 (as amended and delegated to the North West Province) decrees that, subject to regulation 114(2), annual fees as set out in Part C of Schedule 2, shall be paid to the receiver of revenue, (SARS), in respect of each license and this has been a practice throughout the years.

Please note that the Department of Economic Development, Environment, Conservation and Tourism has since been notified by the South African Revenue Services, (SARS) that they will in the future discontinue the collection of revenue generated from payable liquor licenses fees. Subsequent to this notification and after consultation with the Office of the Auditor General, it was decided that all fees as determined and payable towards liquor licenses in the North West Province must henceforth be paid into an account of the Department. In this regard, an arrangement was made with First National Bank whereby all mandatory liquor licenses fees payments will be deposited directly into the account of the Department at the First National Bank (Bathoepole Branch).

Please note also that it will be required that once such a payment has been made at the Bank, a deposit slip of this transaction with a Bank date stamp reflected thereon,

Kindly note that from the date of the publication of this notice, this requirement as entailed herein will be in force for all payments made towards liquor licenses fees and only receipts issued by the Department will be recognised towards a valid liquor license.
