#### **APPLICATION FOR CONSENT TO PROCURE FINANCIAL INTEREST IN PEERMONT GLOBAL (NORTH WEST) (Pty) Ltd BY ISAGO ENTERTAINMENT AND LEISURE (Pty) Ltd**

Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended, that the North West Gambling Board (*"the Board"*) received an application from **Isago Entertainment and Leisure (Pty) Ltd** for consent to procure financial interest in Peermont Global (North West) (Pty) Ltd.

The Board is enjoined by the provisions of section 29 of the North West Gambling Act, 2001 (Act No.2 of 2001) as amended, to cause a notice of this application to be published in the *Provincial Gazette* and newspapers circulating in the district in which the premises to which the application relates are situated, and further invite interested persons to lodge their written representations in relation to the said application.

The provisions of section 27(A) (1) of the North West Gambling Amendment Act , 2005, (Act No. 5 of 2005),states that, "*any person who, directly or indirectly procures a controlling interest or a financial interest of five percent or more, or any lesser percentage as my be prescribed, in the business to which a license or a registration in terms of section 60 relates shall, within the prescribed period and in the manner prescribed or determined by the Board, apply for the consent of the Board to hold such interest"*.

**Isago Entertainment and Leisure (Pty) Ltd**, is a registered company in terms of the Companies Act intending to procure direct financial interest in Peermont Global (North West) Pty Ltd.
