

NOTICE IN TERMS OF SECTION 29 OF THE NORTH WEST GAMBLING ACT, 2001

APPLICATION FOR A CERTIFICATE OF SUITABILITY BY FIDELITY SECURITY SERVICES (Pty) Ltd, TO PROVIDE GAMBLING RELATED SECURITY SERVICES TO SUN INTERNATIONAL SOUTH AFRICA LIMITED trading as, SUN CITY CASINO RESORTS

Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended, that the North West Gambling Board (*"the Board"*) received an application from **Fidelity Security Services (Pty) Ltd**, for a Certificate of Suitability to provide security services to Sun International South Africa Limited, trading as Sun City Casino Resorts.

The Board is enjoined by the provisions of section 29 of the North West Gambling Act, 2001 (Act No.2 of 2001) as amended, to cause a notice of this application to be published in the *Provincial Gazette* and newspapers circulating in the district in which the premises to which the application relates are situated, and further invite interested persons to lodge their written representations in relation to the said application.

The provisions of section 78(1) of the North West Gambling Act, 2001 (Act 2 of 2001), as amended, states that, *"the Board may prohibit a licensee from contracting with any supplier for the purchase of goods or services in terms of this Act, including the rental of premises, or with any lender, until such supplier or lender has obtained a certificate of suitability from the Board and paid the expenses of the Board relative thereto"*.

Fidelity Security Services (Pty) Ltd is a private company registered with the Private Security Industry Regulatory Authority to provide security and related services. The business address of Fidelity is Fidelity Corporate Park, 104D Mimosa Street, Helderkruin, Roodepoort.

Please take note that the application submitted by this company will lie for public viewing in terms of the provisions section 32, of the North West Gambling Act, 2001(Act No.2 of 2001), as amended at the offices of the Board (23 First Street, Industrial Site, **MAHIKENG**), **between 08h30 – 16h30, for a period of one (1) month, commencing on 01 April 2012 to 30 April 2012.**

Persons wishing to make representations, be either comments or objections, in relation to the application submitted by Fidelity Security Services (Pty) Ltd to the Board, shall do so in writing and such representations shall contain the following information:
