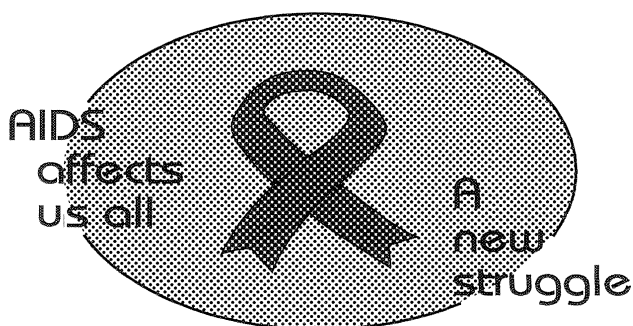

### NOTICE IN TERMS OF SECTION 29 OF THE NORTH WEST GAMBLING ACT, 2001

---

#### APPLICATIONS FOR REMOVAL OF BUSINESS TO OTHER PREMISES IN TERMS OF SECTION 45 OF THE NORTH WEST GAMBLING ACT 2001 (Act No. 2 OF 2001), AS AMENDED.

Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended ("the Act"), that the North West Gambling Board ("the Board") received an application from Santosat (Pty) Ltd, trading as, Viva Bingo North West, for the removal of its Bingo business from the current approved premises to the newly identified premises as mentioned in the paragraphs below.

The Board is enjoined by the provisions of section 29 of the Act, to cause a notice to be published in the *Provincial Gazettes* and in any newspapers circulating in the district where the premises to which the application relates are situated, and further invite interested persons to lodge their written representations relating to the said application.

Santosat (Pty) Ltd is a registered company in terms of Companies Act, with its business address situated at 66 Ontdekkers Road Roodeport, and was granted a Bingo licence during October 2010 to conduct Bingo operations at shop No 37 River Walk Shopping Center, situated at Corner Nelson Mandela and Goven Mbeki Drive in Potchefstroom.

Santosat (Pty) Ltd has lodged an application in terms of the provisions of section 45 of the Act to remove the Bingo premises from **shop No 37 River Walk Shopping Centre, situated at Corner Nelson Mandela and Goven Mbeki Drive in Potchefstroom**, to the new premises situated at **shop No 99 Mooi River, situated at Corner Nelson Mandela and Goven Mbeki Drive in Potchefstroom**.

The provisions of section 45 of the North West Gambling Act, (Act No. 2 of 2001) as amended, states that "*the holder of a license may at any time make an application for removal, whether temporarily or permanently, of the gambling business concerned, from the licensed premises to other premises*".

Please take note that these applications will lie for public inspection at the offices of the Board, 23 First Street, Industrial Site, Mahikeng, **between 08h30 – 16h30, for a period of one (1) month commencing from 01 July 2012 to 31 July 2012.**

**Persons wishing to make representations, be either comments or objections, in relation to any application submitted to the Board, shall do so in writing and such representation shall contain the following information:**

- a) The name of the person to which representations relate;
- b) The grounds on which representations are made;
- c) The name, address, telephone, and facsimile numbers of the person submitting representations; and
- d) Whether or not the person making representations wish to make an oral presentation at the hearing of the applications.
