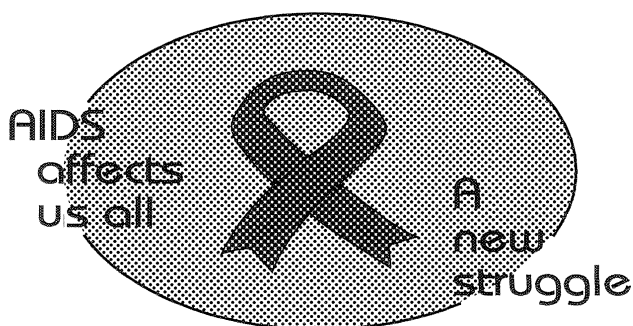

## GENERAL NOTICE

### NOTICE 416 OF 2012

#### URGENT PUBLIC NOTICE FOR LIQUOR LICENSE HOLDERS AND APPLICANTS:

Licenses payments will no longer be made at **South African Revenue Services**. Payments for liquor licenses will be made at any **First National Bank in RSA**.

#### 1. PAYMENTS FOR APPLICATIONS FOR A NEW LICENCE, TEMPORARY, OCCASSIONAL, TRANSFER AND REMOVAL OF A LICENCE, SECTION 38 AND COPIES FOR DOCCUMENTS IN THE FILE.

All applications for new liquor, temporary, occasional licence, transfer, procuring interest and removal of a liquor license are still lodged with respective district magistrates.

Payments in respect of lodgement fees are payable at FNB Bank. Please note the following:-

- **Only** cash deposit or electronic transfer will be accepted.
- No bulk payments for more than one application will be accepted and payments must be effected against each application with correct referencing.
- The onus is with applicant to submit proof of payment in respect of lodgement/ application of any liquor licence together with the first two pages of the application form to The Department of Economic Development, Environment, Conservation and Tourism –018 387 7943/921 within five days (5) from date of payment to issue a receipt
- All payment for liquor license lodgement/applications under this category are classified as **code 809823** for referencing purposes.

#### 2. PAYMENTS FOR ACTIVATION OF A NEW LIQUOR LICENSE, TRANSFER, PROCURING INTEREST AND REMOVAL OF A LIQUOR LICENSE

All payments for activation of liquor licenses will be payable at FNB Bank. License holders should note the following:-

- **Only** cash deposit or electronic transfer will be accepted.
- No bulk payments for more than one license will be accepted and payments must be effected against each license with correct referencing.
- The onus is with the license holder to submit proof of payment in respect of activation of any liquor license together with copy of Form 4, Form 11 or Form 15 to the Department of Economic Development, Environment, Conservation and Tourism –018 387 7943/921 within five days (5) from date of payment to issue a receipt
  - All payment under this category are classified as code 813823 for referencing purposes.

#### 3. PAYMENTS FOR RENEWAL OF A LIQUOR LICENSE FOR 2013

The 2013 renewal period for all liquor licenses will commence as from 1<sup>st</sup> October 2012. License holders are reminded to renew their licenses before 31<sup>st</sup> December 2012 to enable them to trade in liquor for year 2013. Failing to renew liquor license on or before 31<sup>st</sup> December 2012, license holders can renew in January 2013 with 50% penalty or in February with 100% penalty.

Any liquor license not renewed by 28 February 2013 will lapse and license holder will have to lodge an application for a new license.

Renewal Notice for 2013 (FORM 22) will be issued as from 1<sup>st</sup> October 2012 and forwarded to license holders by **ordinary mail**. Please note the following:-

- Receiving a FORM 22 does not validate your license if it has already lapsed and no refunds will be made against payments received in this regard.
- The onus is on the license holder to ensure that no double payments are made when not due as no refunds will be entertained.
- No bulk payments for more than one license will be accepted and payments must be effected against individual liquor license with correct referencing.
  - **Only** cash deposits and electronic transfer will be acceptable.
  - All renewal payments are classified as code number 03 for referencing purposes.
- The proof of payment in respect of renewal fees must be submitted to 018-3877920 or [nmabadi@nwpg.gov.za](mailto:nmabadi@nwpg.gov.za) or by post together with Renewal Notice Form 22 stipulating the contact details of the license holder.

**NB: All licenses that were issued in terms of s19 (FORM 4) as from 1 July 2012 are not subject to renewal at the end of 2012**

All payments for liquor licensing will be payable at any **FNB Bank** using cash deposit or electronic transfer only. As from 1<sup>st</sup> October 2011, SARS will no longer accept payments for liquor licensing.
