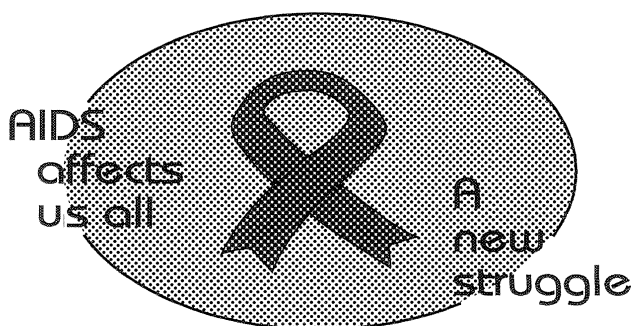

### ASSESSMENT OF GENERAL RATES FOR 2012/2013

Notice is hereby given in terms of Section 14 of the Local Government Municipality Property Rates Act No 6 of 2004, that by Resolution taken on the 22<sup>nd</sup> March 2012 the council of Matatiele Local Municipality has resolved to determine the rates payable on all rateable property within the area of Matatiele Local Municipality for the financial year 01 July 2012 to 30 June 2013 as 0.01669 cents in the rand on the market value of all property other than agricultural property and public service infrastructure and 0.00348 cents in the rand for agricultural properties and 0.01391cents in the rand for public service infrastructure as stated in the valuation roll.

The following rebates and discounts have been approved as per the above Council resolution:

- Residential properties – First R30,000 discount and 35 % Rebate.
- Commercial properties – 10% Rebate.
- Agricultural properties – Apply for R30,000 residential discount.

Overall:

1. Rates will be payable monthly in ten (10) equal instalments with the first Instalment payable on 30 August 2012 and the last instalment payable on 31 May 2013.
2. Application for rates to be paid annually can be done at the Finance Office, 104 High Street, Matatiele.
3. A rebate at Council's discretion is applicable to all Pensioners meeting the Criteria as determined by Matatiele Council. Applications close 31 July 2012.
4. The date on which the determination of rates come into operation is 01 July 2012.
5. Any rates remaining unpaid for a period longer than 3 months will be subject to legal action, action to be instituted to recover the arrear amount.
6. Any rates that are not paid on the due date will be subject to interest at the rate of 1.8% per month or part thereof.
