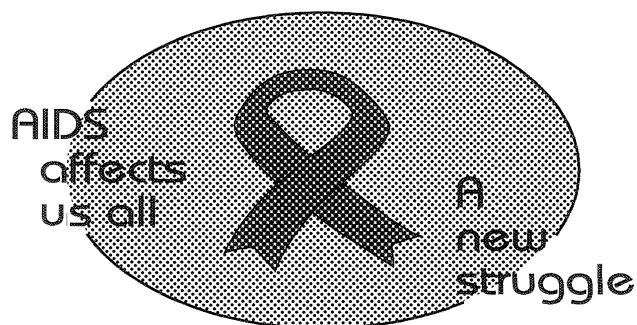

Page 9: *Wording for Heading 'SCOPE OF THE POLICY' is amended, and read as 'SCOPE OF THE BY-LAW'. The word 'policy' on the first and last sentences under same heading is amended, and read as 'by-law'.*

*The word 'policy' on paragraph under heading 'APPLICATION OF THE BY-LAW' is amended, and read as 'by-law'*
