### PUBLIC NOTICE CALLING FOR INSPECTION OF SUPPLEMENTARY VALUATION ROLL AND LODGING OF OBJECTIONS

Notice is hereby given in terms of sections 78(2) of the Local Government: Municipal Property Rates Act, 2004 [Act no.6 of 2004], hereinafter referred to as the "Act", that the supplementary valuation roll is open for public inspection as the municipal offices in Brits, Hartbeespoort, Damonsville, Mothoflung, Oukasie, Lethabile and Lethabong from 12 November 2013 to 12 December 2013
