An invitation is hereby made in terms of section 49(1)(1(a)(i) of the act that any owner of property or other person who so desires should lodge an objection with the municipal manager in respect of any matter reflected in, or omitted from, the valuation roll within the above-mentioned period.

Attention is specifically drawn to the fact that in terms of section 50(2) of the Act an objection must be in relation to a specific property and not against the valuation roll as such. The completed form must be returned to one of the municipal offices listed below before or on 24 April 2014. **No objections received by fax or e-mail will be accepted.**
