



#### PUBLIC NOTICE FOR INSPECTION OF A GENERAL VALUATION ROLL

Greater Taung Local Municipality gives notice in terms of Section 49(1)(a) of the Local Government Municipal Property Rates Act (No. 06 of 2004), hereinafter referred to as the Act, that the General Valuation Roll for the financial years 2014 – 2018 stated in terms of Section 30 of the Act is open for public inspection in the following municipal offices: Taung, Pudumoe and Reivilo.

According to section 50(2) of Municipal Property Rates Act no.6 of 2004, an objection in terms of subsection (1)(c) must be in relation to a specific individual property and not against the valuation roll as such.

The objection forms is obtainable from the Municipal Cashiers offices or can be downloaded from the Municipal website [www.greatertaung.gov.za](http://www.greatertaung.gov.za) . Completed forms must be submitted to the attention of Municipal Manager and addressed to: Greater Taung Local Municipality, Private Bag X1048, Taung Station, 8580 or by hand to the nearest municipal administration offices: Taung, Pudumoe and Reivilo. The objections are open until 31st March 2014, during office hours (08h00 to 16h30) or on Municipal website: [www.greatertaung.gov.za](http://www.greatertaung.gov.za).
