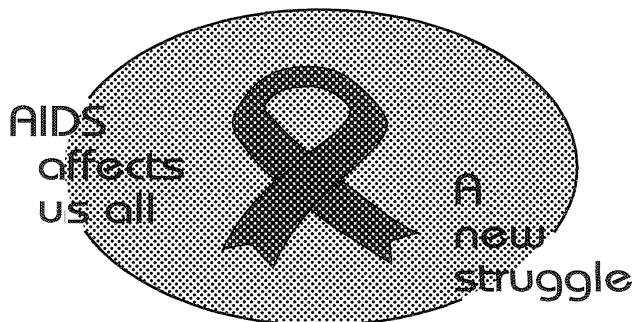

PUBLIC NOTICE CALLING FOR INSPECTION OF THE GENERAL VALUATION ROLL AND LODGING OF OBJECTIONS



Notice is hereby given in terms of Section 49(1)(a)(i)(c) of the Local Government: Municipal Rates Act, 2004 (Act No. 6 of 2004), herein referred to as the "Act", that the valuation roll for the financial years 01 July 2014 to 30 June 2018, is open for public inspection at the addresses listed below, from 21 February 2014 till 20 April 2014 during office hours. In addition the valuation roll is available at this Municipality's official website: www.bushbuckridge.gov.za, as it was published on the 21 February 2014.

An invitation is hereby made in terms of the Section 49(1)(a)(ii) of the Act that any owner of a property or other person who so desires can lodge an objection with the municipal manager in respect of any matter reflected in, or omitted from the valuation roll within the abovementioned period.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act, an objection must be in relation to a specific individual property and not against the valuation roll as such. The form for the lodging of an objection is obtainable at the address listed below, or at the following website: www.valuersafrika.co.za.

The completed form must be returned to one of the addresses listed below before or on 09 May 2014.
No objections received by fax or e-mail will be accepted.

Please note the following:

- A) The date of valuation 2 July 2013.
- B) The amount of property rates payable on the new valuation is not yet determined.
- C) The new tariff will be established during the budget process.
