##### NOTICE IN TERMS OF SECTION 29 OF THE NORTH WEST GAMBLING ACT, 2001 (ACT No. 2 OF 2001), AS AMENDED

##### APPLICATION FOR REMOVAL OF BUSINESS TO OTHER PREMISES IN TERMS OF SECTION 45 OF THE NORTH WEST GAMBLING ACT, 2001.

Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended ("the Act") that, the North West Gambling Board ("the Board") received an application from Galaxy Bingo North West (Pty) Ltd for removal of business to other premises.

This notice seeks to implement the settlement agreement of the dispute between the North West Gambling Board and Galaxy Bingo North West (Pty) Ltd regarding the granting of the applications for the Bingo licences. The settlement between the parties was to the following effect:

1. That the Board shall grant a Bingo licence to Galaxy Bingo North West (Pty) Ltd as it was intended for operations in Rustenburg; and
2. That Galaxy Bingo North West (Pty) Ltd shall submit an application for the transfer of the aforesaid licence to the premises yet to be identified in Klerksdorp, and should the aforesaid application not be approved, Galaxy Bingo North West (Pty) Ltd shall be allowed to transfer same to any other suitable place in the North West Province, where there are no Bingo licences approved.

Galaxy Bingo North West (Pty) Ltd lodged the application in response to the settlement agreement, in terms of the provisions of section 45 of the Act, for the removal of the Bingo business from the licensed premises at **Waterfall Mall in Rustenburg**, to other premises at **Shop no. 31 Matlosana Mall in Klerksdorp**.

Please take note that this application will lie for public inspection at the offices of the North West Gambling Board at 131 University Drive, Mmabatho, **between 08h30 – 16h30, for a period of one (1) month, commencing from 01 September 2014 to 30 September 2014.**
