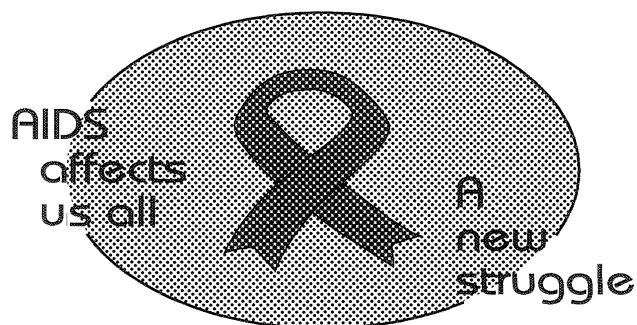

#### DEPARTMENT OF ECONOMY AND ENTERPRISE DEVELOPMENT

#### CALL FOR NOMINATIONS FOR MEMBERS TO FILL VACANCIES IN THE NORTH WEST GAMBLING BOARD

The North West Gambling Board (“**the Board**”) is a Schedule 3C Public Entity in terms of the Public Finance Management Act 1999 ( Act No 1 of 1999), responsible for overseeing gambling activities in the North West Province.

The Member of the Executive Council responsible for Finance, Economy and Enterprise Development, Mrs Wendy Nelson is inviting interested parties to submit nominations for the appointment of additional members to the Board, as required by the provisions of Section 5 of the North West Gambling Act,2001 (Act No 2 of 2001) as amended.(“the Act”)

There are currently three (3) vacancies in the Board to be filled by nominees who meet the following criteria;

- One member who is qualified to be admitted to practice as a legal practitioner and after having so qualified , practised as a legal practitioner or performed services related to the application or administration of the law, to be appointed as per the provisions of section 5(1)(a) of the Act;
- One member who is an accountant, or an auditor registered in terms of the Public Accountant’s and Auditors Act 1991 ( Act No 80 of 1991,and *preferably* a Chartered Accountant to be appointed as per the provisions of section 5(1) (b) of the Act; and
- One member who has knowledge and experience in the field of welfare or socio-economic development to be appointed as per the provisions of Section 5(1)(c) of the Act.

The following persons are not eligible for appointment to the Board: Public servants\* a member of Parliament, the National Council of Provinces or a Provincial Legislature, \*Political Office bearers,\* persons having direct or indirect interest in any gambling activity or any other business or enterprise that may conflict with the proper performance of his or her duties as a member of the Board. Preference shall be given to the residents of the North West Province. Kindly note that all eligible nominees will be subject to vetting processes.

Nominations should be in writing and must have the following details: full names of the persons nominating the candidate and the Curriculum Vitae (CV) of the candidate. The Curriculum Vitae of the candidate must include: the candidate's full names; identity number and gender; contact address; contact numbers; fax numbers and e-mail address(if any); experience knowledge and skills, certified copies of academic qualifications and supporting information and names and contact details of at least two (2) referees. A signed letter of acceptance of the nomination from the candidate.

Please note that this is a re-advertisement and persons who previously submitted nominations are encouraged to submit again.
