

**PROVINCIAL NOTICE 142 OF 2016****DEPARTMENT OF LOCAL GOVERNMENT AND HUMAN SETTLEMENTS****LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998 (ACT 117 OF 1998)****NOTICE IN TERMS SECTION 14(5)**

I, Galaletsang Fenny Gaolaolwe, Member of Provincial Executive Council responsible for Department of Local Government and Human Settlements, under Section 19054 of the Local Government: Municipal Structures Act, 1998 (Act 117 of 1998), and after consultation with the affected municipalities, hereby amend the Extraordinary Provincial Gazette No. **7644 dated 13 May 2016** in respect of transitional arrangements for the amalgamation of Tlokwe and Ventersdorp local municipalities, by directing that additional conditions be strictly observed as contained in the schedule.

**SCHEDULE**

The following conditions shall apply in respect of transitional arrangements for the amalgamation of Tlokwe and Ventersdorp local municipalities:

- 1.1 The existing rates policies of the disestablished municipalities shall remain valid until the established local municipality has prepared a new rates policy for the newly established local municipality.
- 1.2 Any by-laws or action taken in terms of a by-law, town planning scheme and policy referred to above, must be applied or carried out by the newly established municipality to the extent that the by-law, scheme or policy is applicable in the newly established municipality. Any reference in such by-laws, Scheme or policy or action applied or carried out in terms thereof, to a disestablished municipality shall be deemed to be a reference to the newly

established municipality and any structure or functionary of a disestablished municipality shall be deemed to be a structure or functionary of the newly established municipality.

- 1.3 The valuation rolls and supplementary of the disestablished municipalities which cover the area of the municipality remain valid for the area covered by it until the municipality has prepared a combined General valuation roll for the area of jurisdiction of the new municipality.
- 1.4 If a newly established municipality uses valuation rolls and supplementary valuation rolls in terms of subsection(3) that newly established municipality may, notwithstanding section 19(1) (a) of the Local Government : Municipal Property Rates Act. No 06 of 2004, impose different rates based on the different valuation rills or supplementary valuation rolls, so that the amount in the Rand on the market value of the property payable on similarly situated property is more or less the same.
