### EXPRESSION OF INTEREST IN PROPOSALS FOR A CASINO LICENCE - NORTH WEST PROVINCE

Following the re-allocation of an additional Casino Licence to the North West Province by the Minister of Trade and Industry, the North West Gambling Board (*“the Board”*) intends to commence with the process of licensing a fifth Casino in the Province. The Board would like to ensure that this licence serves as a catalyst for socio-economic development and growth of the area where it will be located. To this end, the ideal concept of a Casino Licence should display a combination and development of a number of recreational facilities, which will serve as an attraction for a maximum number of visitors in order to enhance opportunities for Rebranding, Repositioning and Renewal of the North West Province.

Without derogating from the policy adopted by the Board regarding the location of this fifth Casino, a number of areas have been identified where the placement of a casino can possibly achieve the desired objectives.

In light of this background, the Board wishes to invite interested parties to express interest in the proposal for the Fifth Casino Licence in the Province. A submission expressing interest should amongst others, include the following:

- Closest town/s to the location where the casino will be situated;
- Project Theme, description (including a list of major facilities forming part of the project), planned development phases and duration;
- Size of the project (expressed in m<sup>2</sup>, number of gambling machines, gambling tables and any other form of gambling activity, including all relevant indicators for such facilities);
- Projected annual revenue from gambling activities,
- Detailed outline of intended entertainment facilities (other); and
- Ballpark investments amount (rand value).

The information submitted in respect of this notice will be dealt with confidentially by the Board and will not be made public without prior approval of the concerned parties.
