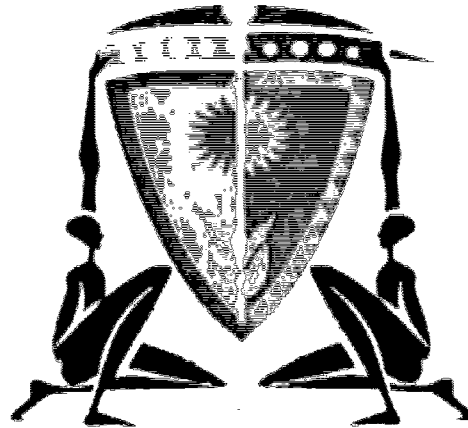

GENERAL CONDITIONS WITH REGARDS TO THE PAYMENT OF THE TARIFFS AS SET OUT ABOVE

All registration certificates and permits must be renewed before or on 31 December of every year.

Temporary registration for special events is charged per day to a maximum of 15 days per year. Should a vendor require a permit for more than 15 days per year, the normal registration fee will be charged.

All moneys are payable in advance.

All relevant application forms are available at the Public Safety Directorate (Fire Brigade Services Section) and must be completed in full and where applicable properly signed.

If registration certificates are refused, remedial steps must be taken within fourteen(14) days by the applicant in order for the re-inspection to be free of charge and to ensure the issuing of the relevant registration certificate or permit. Failing this, the prescribed tariffs will again be payable in full.
