

PROCLAMATION IN TERMS OF SECTION 137 (A) AND (B), READ WITH SECTION 140(1)(B) AND (2) OF THE CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, 1996: TRANSFER OF THE ADMINISTRATION OF THE NORTH WEST DEVELOPMENT CORPORATION ACT, 1996 (ACT NO. 6 OF 1996) AND LEGISLATIVE OVERSIGHT FUNCTIONS AND RESPONSIBILITIES OVER THE NORTH WEST DEVELOPMENT CORPORATION, FROM THE PREMIER TO MEMBER OF THE EXECUTIVE COUNCIL FOR FINANCE ECONOMY AND ENTERPRISE DEVELOPMENT

By virtue of the powers vested in me in terms of section 137(a) and (b), read with section 140(1)(b) and (2) of the Constitution of the Republic of South Africa, 1996, I Tebogo Job Mokgoro, in my capacity as Premier of the North West Province, hereby transfer the administration of the North West Development Corporation Act, 1996 (Act No. 6 of 1996), and all legislative oversight functions and responsibilities over the North West Development Corporation, from the Premier, to the Member of the Executive Council responsible for Finance Economy and Enterprise Development, with effect from 01 April 2018.
