NOTICE IN TERMS OF SECTION 29 OF THE NORTH WEST GAMBLING ACT,  
2001 (ACT No. 2 OF 2001), AS AMENDED.

**APPLICATION FOR A NATIONAL LICENCE AS A MANUFACTURER OF GAMBLING  
EQUIPMENT BY RST COMPANY (PTY) LTD.**

Notice is hereby given in terms of the provisions of section 29 of the North West Gambling Act, 2001 (Act No. 2 of 2001), as amended, that the North West Gambling Board (*"the Board"*) received an application from RST Company (Pty) Ltd for a National Licence as a Manufacturer of gambling equipment in terms of section 38 of the National Gambling Act (NO. 7 of 2004).

In terms of the provisions of section 38 (2) of the National Gambling Act (NO. 7 of 2004), *"An applicant may apply to a provincial licensing authority for either a provincial licence in terms of applicable provincial law or a national licence, if the applicant seeks—*

*(a) a licence as a manufacturer, supplier or maintenance provider "*.

**RST Company (Pty) Ltd**, is a company registered to manufacture gambling machines, betting software, hardware and infrastructure. The company is incorporated in the Republic of South Africa in 2018 in terms of the Companies Act, 2008 with the following Registration No: **2018/371106/07**. The registered place of business is 37 Fricker Road, Illovo in Johannesburg.

Please take note that this application will be lying open for public viewing at the offices of the North West Gambling Board, 131 University Drive, Mmabatho **between 08h30 – 16h30, for a period of one (1) month, commencing on 01 September 2018 to 30 September 2018.**

**Persons wishing to make representations, be it either comments or objections, in relation to any application submitted to the Board, shall do so in writing and such representations shall contain the following information:**

- a) The name of the applicant to which representations relate;
- b) The grounds on which representations are made;
- c) The name, address, telephone, and facsimile numbers of the person submitting representations; and
- d) Whether or not the person making representations wish to make an oral presentation at the hearing of the application.
