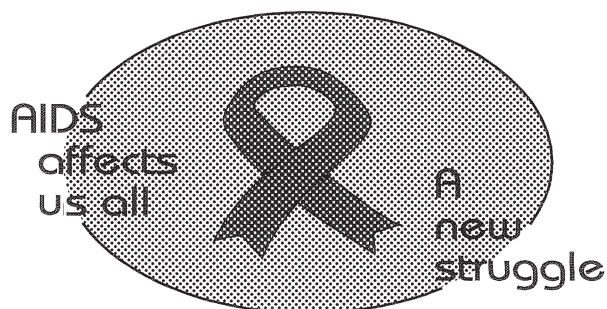

There is no form to complete, but an objection must include:

- the objector's full names, postal address residential or office address telephone and or cellular phone number and email address;
- particulars of candidate whose nomination is objected against;
- grounds/ reasons for making the objection; and
- Details of supporting documents accompanying the notice of objection.

In terms of section 5(5) of the North West Gambling Act, any person may object to the nomination of a candidate to serve on the North West Gambling Board
