WESTERN CAPE GAMBLING AND RACING LAW, 1996  
(LAW 4 OF 1996):

**AMENDMENT OF WESTERN CAPE GAMBLING AND  
RACING REGULATIONS**

Under the powers vested in me by section 81 of the Western Cape Gambling and Racing Law, 1996 (Law 4 of 1996), I, Johan Gelderblom, in my capacity as member of the Executive Council responsible for the administration of the said Law, hereby amend the Western Cape Gambling and Racing Regulations published under Provincial Notice 303/1997 of 29 August 1997, as amended under Provincial Notice 331/1998 dated 19 June 1998, Provincial Notice 363/2000 dated 16 August 2000 and Provincial Notice 24/2001 dated 2 February 2001, as follows:

1. Regulation 25 is hereby amended by the insertion after subregulation (2) of the following subregulations—

“(2A) The holder of a licence issued in terms of paragraph (a), (b), (d), (i), or (k) of section 27 of the Law must ensure that a notice informing the public of the phenomenon of compulsive or problem gambling or betting is prominently displayed at the following places on the licensed premises concerned:

- (i) at every entrance within the premises which permits access to any specifically demarcated area where betting or gambling takes place, and
- (ii) in the case of the licensed premises of a holder of a totalisator operator licence who permits the holder or holders of a bookmaker licence or licences to accept bets at specifically allocated positions on the licensed premises covered by the totalisator operator licence, at such places as the Board, in writing, after an inspection of the specifically allocated positions, informs the holder or holders of the bookmaker licence or licences concerned.

(2B) The notice required by subregulation (2A)—

- (i) shall contain contact details of facilities which provide assistance to persons who suffer, or who may suffer, from compulsive or problem gambling or betting, and
- (ii) shall be of such size and in such format as is required by the Rules of the Board.

(2C) The holder of a licence referred to in subregulation (2A) shall ensure that there is on the licensed premises concerned, an adequate supply of pamphlets for public reference and use, concerning the phenomenon of compulsive or problem gambling or betting.

(2D) The location of the pamphlets referred to in subregulation (2C), and the details regarding the phenomenon of compulsive or problem gambling or betting to be contained in those pamphlets, shall be determined by the Rules of the Board.”.

WES-KAAPSE WET OP DOBBELARY EN WEDRENNE, 1996  
(WET 4 VAN 1996):

**WYSIGING VAN WES-KAAPSE DOBBELARY EN  
WEDRENNE REGULASIES**

Kragtens die bevoegdheid aan my verleen by artikel 81 van die Wes-Kaapse Wet op Dobbelary en Wedrenne, 1996 (Wet 4 van 1996), wysig ek, Johan Gelderblom, in my hoedanigheid as lid van die Uitvoerende Raad verantwoordelik vir die administrasie van genoemde Wet, hierby die Wes-Kaapse Regulasies insake Dobbelary en Wedrenne, gepubliseer by Provinsiale Kennisgewing 303/1997 van 29 Augustus 1997, soos gewysig by Provinsiale Kennisgewing 331/1998 van 19 Junie 1998, Provinsiale Kennisgewing 363/2000 van 16 Augustus 2000 en Provinsiale Kennisgewing 24/2001 van 2 Februarie 2001, soos volg:

1. Regulasie 25 word hiermee gewysig deur die volgende subregulasies na subregulasie (2) in te voeg—

“(2A) Die houer van ’n lisensie uitgereik in terme van paragraaf (a), (b), (d), (i) of (k) van artikel 27 van die Wet moet verseker dat ’n kennisgewing, wat die publiek inlig oor die verskynsel van kompulsiewe of probleemdobbelary of -wedderly duidelik by die volgende plekke op die betrokke gelisensieërde perseel vertoon word:

- (i) by elke ingang binne die perseel waar toegang toegelaat word na ’n spesifieke afgebakende area waar wedderly of dobbelary plaasvind, en
- (ii) in die geval van ’n gelisensieërde perseel van die houer van ’n totalisator operateurlisensie wat die houer of houters van ’n boekmakerslisensie of lisensies toelaat om weddenskappe te aanvaar by spesifiek geallokeerde posisies op die gelisensieërde perseel wat deur die totalisator operateurlisensie gedek word, by sodanige plekke soos wat die Raad, die houer of houters van die betrokke boekmakerslisensie of lisensies, na ’n inspeksie van die spesifiek geallokeerde posisies, skriftelik inlig.

(2B) Die kennisgewing deur subregulasie (2A) vereis—

- (i) moet kontakbesonderhede van fasiliteite wat hulp verleen aan persone wat aan kompulsiewe of probleemdobbelary of -wedderly ly of mag ly bevat, en
- (ii) moet van die grootte en in die formaat wees soos deur die Reëls van die Raad vereis.

(2C) Die houer van ’n lisensie beoog in subregulasie (2A) moet verseker dat daar op die betrokke gelisensieërde persele ’n genoegsame voorraad is van pamflette rakende die verskynsel van kompulsiewe of probleemdobbelary of -wedderly vir publieke verwysing en gebruik.

(2D) Die plasing van die pamflette in subregulasie (2C) beoog, en die besonderhede rakende die verskynsel van kompulsiewe of probleemdobbelary of -wedderly wat in die pamflette vervat moet word, sal deur die Reëls van die Raad bepaal word.”.
