**ELECTORCAL COMMISSION  
ELECTION TIMETABLE**

The Electoral Commission hereby gives notice that it has in terms of section 11 of the Local Government: Municipal Electoral Act, 2000, compelled the election timetable set out below to apply to the municipal by-elections to be held on 11 February 2004 in respect of Ward 42 of the City of Cape Town Municipality as proclaimed by Provincial Notice Number 1 of 2004 as published in the Provincial Gazette Extraordinary No. 6097 of the Western Cape Province dated 9 January 2004. A reference to "section" in this election timetable is a reference to that section in the Local Government: Municipal Electoral Act, 2000 (Act No. 27 of 2000).

**CUT-OFF TIME FOR ACT TO BE PERFORMED**

An act required in terms of this Act to be performed by not later than a date in the election timetable must be performed before 17:00 on that date, unless otherwise specified.

**CERTIFICATION OF THE VOTERS' ROLL**

By 14 January 2004 the chief electoral officer must certify the segments of the voters' roll for the voting districts to be used in the by-elections in terms of section 6(2)(a).

**NOTICE THAT LISTS OF ADDRESSES OF VOTING STATIONS  
ARE AVAILABLE FOR INSPECTION**

By 14 January 2004 the chief electoral officer must give notice that copies of a list of voting stations and their addresses will be available for inspection at the office of the Commission's local representative in terms of section 19(5).

**NOTICE OF ROUTE OF MOBILE VOTING STATIONS**

If the Commission decides to use mobile voting stations in the by-elections, the Commission must by 14 January 2004 give notice of the route, including the locations and estimated times of stopping of each mobile voting station in terms of section 22(1).

**CUT-OFF DATE FOR NOMINATION OF WARD CANDIDATES  
TO CONTEST AN ELECTION**

By not later than 28 January 2004 at 17:00, the nomination of a person to contest the by-election in a municipality as a ward candidate, must be submitted to the Commission's local representative on a prescribed form and in the prescribed manner in terms of section 17(1).

**CUT-OFF DATE FOR COMPILATION AND CERTIFICATION  
OF WARD CANDIDATE LISTS**

By 29 January 2004 the Commission must compile for each ward a list of ward candidates, certify those lists for that by-election, and keep copies of the lists available at the office of the Commission's local representative in terms of section 18(1).

**CUT-OFF DATE FOR ISSUING CERTIFICATES**

By 30 January 2004 the Commission must issue to each ward candidate contesting the by-election, a prescribed certificate in terms of section 18(1)(d).

**KENNISGEWING DAT ADRESLYS VAN STEMLOKALE TER  
INSAE BESKIKBAAR IS**

Teen 14 Januarie 2004 moet die hoofverkiesingsbeampte kennis gee dat afskrifte van 'n lys van alle stemlokale en hul adresse ter insae beskikbaar sal wees by die kantoor van die Kommissie se plaaslike verteenwoordiger in terme van artikel 19(5).

**KENNISGEWING VAN ROETE VAN MOBIELE STEMLOKALE**

**SPERDATUM VIR DIE SAMESTELLING EN SERTIFISERING  
VAN WYKSKANDIDAATLYSTE**

Teen 29 Januarie 2004 moet die Kommissie vir elke wyk 'n lys van wykskandidate opstel, daardie lys vir die tussenverkiesing sertifiseer, en afskrifte van die lys by die kantoor van die Kommissie se plaaslike verteenwoordiger in terme van artikel 18(1) ter insae beskikbaar stel.

**SPERDATUM VIR DIE UITREIKING VAN SERTIFIKATE**

Teen 30 Januarie 2004 moet die Kommissie aan elke wykskandidaat wat aan die tussenverkiesing deelneem 'n voorgeskrewe sertifikaat in terme van artikel 18(1)(d) uitreik.
