(DC2) SIXTH ESTABLISHMENT AMENDMENT NOTICE**

By virtue of the powers vested in me by section 16 of the Local Government: Municipal Structures Act, 1998 (Act 117 of 1998), as amended, I hereby give notice of the sixth amendment of the Cape Winelands District Municipality (DC2) Establishment Notice, Provincial Notice 486 published in the Provincial Gazette Extraordinary No. 5590 dated 22 September 2000 (the Principal Notice), as amended by Provincial Notice 672 published in the Provincial Gazette Extraordinary No. 5642 dated 4 December 2000, Provincial Notice 453 published in the Provincial Gazette Extraordinary No. 5968 dated 19 December 2002, Provincial Notice 181 published in the Provincial Gazette Extraordinary No. 6020 dated 28 May 2003, Provincial Notice 162 published in the Provincial Gazette No. 6160 dated 20 August 2004 and Provincial Notice 8 published in the Provincial Gazette Extraordinary No. 6333 dated 3 January 2006, on the terms set out in the Schedule hereto.

SCHEDULE

Amendment of principal Notice

1. Section 8 is amended by the substitution thereof of the following section:—

“8. The Municipal Council of the District Municipality has 36 (thirty six) councillors, as determined by the Provincial Minister in Provincial Notice 100/2004 published in Provincial Gazette No. 6137 of 8 June 2004, of which:—

- (a) 15 (fifteen) proportionally represent the parties contesting the election in the District Municipality in terms of section 23(1)(a) of the Municipal Structures Act;
- (b) 20 (twenty) directly represent the Local Municipalities in terms of section 23(1)(b) of the Municipal Structures Act, of which:—
 - (i) 2 (two) directly represent the Witzenberg Municipality (WCO22);
 - (ii) 7 (seven) directly represent the Drakenstein Municipality (WCO23);
 - (iii) 4 (four) directly represent the Stellenbosch Municipality (WCO24);
 - (iv) 5 (five) directly represent the Breede Valley Municipality (WCO25), and
 - (v) 2 (two) directly represent the Breede River/Winelands Municipality (WCO26), and
- (c) 1 (one) proportionally represent the parties contesting the election in the District Management Area in terms of section 23(1)(c) of the Municipal Structures Act.”.

Short title and commencement

2. This Notice is called the Cape Winelands District Municipality (DC2) Six Establishment Amendment Notice and comes into operation on the date of publication.

Wysiging van Hoofkennisgewing

1. Artikel 8 word gewysig deur dit met die volgende artikel te vervang:—

“8. Die Munisipale Raad van die Distriksmunisipaliteit het 36 (ses-en-dertig) raadslede, soos bepaal deur die Provinsiale Minister in Provinsiale Kennisgewing 100/2004, gepubliseer in Buitengewone Provinsiale Koerant No. 6137 van 8 Junie 2004, van wie:—

- (a) 15 (vyftien) die partye wat ingevolge artikel 23(1)(a) van die Munisipale Strukturewet aan die verkiesing in die Distriksmunisipaliteit deelneem, proporsioneel verteenwoordig;
- (b) 20 (twintig) die Plaaslike Munisipaliteit ingevolge artikel 23(1)(b) van die Munisipale Strukturewet regstreeks verteenwoordig, van wie:—
 - (i) 2 (twee) die Munisipaliteit Witzenberg (WCO22) regstreeks verteenwoordig;
 - (ii) 7 (sewe) die Munisipaliteit Drakenstein (WCO23) regstreeks verteenwoordig;
 - (iii) 4 (vier) die Munisipaliteit Stellenbosch (WCO24) regstreeks verteenwoordig;
 - (iv) 5 (vyf) die Munisipaliteit Breede Vallei (WCO25) regstreeks verteenwoordig, en
 - (v) 2 (twee) die Munisipaliteit Breërivier/Wynland (WCO26) regstreeks verteenwoordig, en
- (c) 1 (een) die partye wat ingevolge artikel 23(1)(c) van die Munisipale Strukturewet aan die verkiesing in die Distriksbestuursgebied deelneem, proporsioneel verteenwoordig.”.

Korttitel en inwerkingtreding
