BILL

To repeal the Ambulance Personnel Transfer and Pensions Ordinance, 1955, and to provide for matters incidental thereto.

BE IT ENACTED by the Provincial Parliament of the Province of the Western Cape,
as follows:—

Repeal of Ordinance No. 11 of 1955

1. The Ambulance Personnel Transfer and Pensions Ordinance, 1955, is repealed.

Short title

2. This Act is called the Western Cape Ambulance Personnel Transfer and Pensions Ordinance Repeal Act, 2008.

EXPLANATORY MEMORANDUM

1. Proposed Repeal of the Ordinance

- 1.1 The Ambulance Personnel Transfer and Pensions Ordinance, 1955 (Ordinance 11 of 1955) ("the Ordinance") was promulgated to regulate the transfer of personnel of the ambulance services from the Provincial Administration to local government and to regulate matters pertaining to the pension superannuation benefits of the personnel transferred.
- 1.2 In terms of Proclamation No. 115 of 17 June 1994, the administration of this Ordinance was assigned to the Province.
- 1.3 The Ordinance has become redundant as the transfer of public service personnel is currently governed by the Public Service Act, 1994 (Proclamation No. 103 of 1994) and the Labour Relations Act, 1995 (Act No. 66 of 1995). Furthermore, ambulance services is now a provincial function in terms of Part A of Schedule 5 of the Constitution.
- 1.4 The attached Bill has been drafted to repeal the Ordinance.

2. Consultation

The Department of the Premier, Chief Directorate: Legal Services was consulted.

3. Implications

There are no personnel or financial implications.

VERKLARENDE MEMORANDUM

1. Voorgestelde herroeping van die Ordonnansie

- 1.1 Die Ordonnansie op die Oorplasing en Pensioene van Ambulanspersoneel, 1955 (Ordonnansie 11 van 1955) ("die Ordonnansie") is uitgevaardig om die oorplasing van personeel van die ambulansdiens van die Provinsiale Administrasie na plaaslike owerhede te reguleer en om sake verwant aan die pensioenfondsvoordele van oorgeplaaste personeel te reguleer.
- 1.2 Ingevolge Proklamasie Nr. 115 van 17 Junie 1994 is die administrasie van hierdie Ordonnansie oorgedra aan die Provinsie.
- 1.3 Die Ordonnansie het oortollig geraak omdat die oorplasing van personeel tans plaasvind ingevolge die Staatsdienswet, 1994 (Proklamasie Nr. 103 van 1994) en die Wet op Arbeidsverhoudinge, 1995 (Wet Nr. 66 van 1995). Daarbenewens is die ambulansdiens nou 'n provinsiale funksie ingevolge Deel A van Bylae 5 van die Grondwet.
- 1.4 Die aangehegte Wetsontwerp is opgestel om die Ordonnansie te herroep.

2. Oorlegpleging

Oorleg is gepleeg met die Departement van die Premier en die Hoofdirektoraat Regsdienste.

3. Implikasies

Daar is geen personeel- of finansiële implikasies nie.
